Tucson AGBA To Host State Group

TUCSON - The Tucson chapter of the Arizona Gay Barowners Association (TAGBA) is very much alive and making big plans for the fall season on the local Tucson front.

The entire Arizona Gay Barowners Association will hold their September meeting at Colettes West on September 18. On Monday, the evening before, the Tucson members will host a double-decker bus tour of all the Tucson bars for the visiting Phoenix barowners. This event was held last year and proved to be a big success and gave all Tucsonans a chance to meet and greet the Phoenicians.

In addition, TAGBA would like every local member bar to have a team entered in each of the following sports: Softball, Volleyball, Pool, Bowling. All interested parties should sign up at your favorite bar and make Tucson the Gay sports capital of the Southwest.

Since the new "21-year-old drinking law is in effect, all bars will be checking ID's very carefully. Everyone, regardless of age must carry a proper identification, or face being denied entry into the establishment.

TAGBA is also cooperating with each member bar in reporting returned checks. If you have an outstanding "hot" check in one of the member bars, chances are that your name will appear on the list of all member bars. The situation has gotten out of control and drastic measures are called for.

The TAGBA as well as the AGBA was formed to make all bars safe and fun for their clientele. Troublemakers and the like will not be tolerated in member bars, whether in Tucson or in Phoenix. These bars are there for everyone's enjoyment, not for just the few to destroy.

Police Charged With Setting GCN Fire

BOSTON, MA (GCN) - Seven men, including two police officers, two firefighters and a security guard, have been indicted by a federal grand jury on charges of setting 163 fires in the Greater Boston area, including the seven-alarm blaze that destroyed the offices of Gay Community News, Fag Rag and the Glad Day Bookstore on July 7, 1982.

The indictments follow the July 6 sentencing of Boston Police Officer Robert Groblewski, who pleaded guilty last May to charges involving 29 other arson fires. Groblewski, who is currently serving a 12-year federal prison sentence concurrent with a 6 to 10 year sentence on state charges, is listed as an unindicted co-conspirator.

At a press conference announcing the indictments, U.S. Attorney William Weld said Groblewski and the seven others were fire buffs who set the fires with the bizarre intent to create need for police and firefighting personnel laid off in the wake of Proposition 2 1/2, a statewide tax-cutting referendum. Local media have portrayed Groblewski as a 'model cop' led astray by his intense desire to become a firefighter.

Assistant U.S. Attorney Mark Robinson, who is prosecuting the case, said he had "no evidence" the arsonists knew the Bromfield Street building they set ablaze housed the offices of Gay Community News. "There's nothing in the indictment with respect to any motive for burning that address on

Bromfield Street," Robinson told GCN. "There's no indication that anyone knew it was the offices of your newspaper." Asked what evidence prosecutors had that linked the defendants specifically to the GCN fire, Robinson declined comment.

At the time of the fire, several different motives were suggested for the arson. Political attacks on the paper's offices were not unprecedented. In 1978, burglars and vandals broke into the office more than a half a dozen times. In September of that year, shortly after a visit to Boston by anti-Gay crusader Anita Bryant, the office was forcibly entered and ransacked. And bullet holes that appeared in office windows in 1978 served right up to the day of the fire as a constant reminder of the vulnerability of the paper and its staff.

In addition, the Bromfield Street offices were housed in a dilapidated but heavily-insured building, owned by a straw for a wealthy downtown real estate developer, surrounded by expensive new commercial developments, and in a city renowned for arson-for-profit.

All the men except one were arrested on July 25, the day of the indictments. Prosecutors said the arsons which caused more than 280 injuries and destroyed more than \$22 million worth of property, represent the biggest arson case in Massachusetts and U.S. history.

Arizona Gay Off and Running

Arizona Gay will be cablecast on Cox Cable public access channels 37-A and 10-B, four times each week, beginning on Wednesday, Sept. 12, and every Wednesday thereafter at 8:00 p.m.; every Saturday at 4:00 p.m. and every Sunday at 11:00 a.m. and 6:00 p.m.

Arizona Gay already has the endorsement of the Tucson Lesbian and Gay Pride Committee and The Observer and it is hoped that every other organization who is interested in the advancement of the Tucson Lesbian/Gay community will follow with their endorsements.

On September 19, Arizona Gay will be taping shows three and four - "Love One Another" - Gays and Religion with representatives from Metropolitan Community Church (MCC) and other Gay

religious organizations and "Silver Gay" - Gays over 40. If you would like to take part in these shows as a guest or as a member of the audience, please call 293-0184 for further information.

Producer/Director of Arizona Gay, Jim Farias stated, "We will need help with many things in the coming weeks. If anyone can spare the time to help, please call and let us know what time you have available and we'll tell you how you can help. One of our most pressing needs is still to find resources of funding to cover the expenses of putting the show on. We are especially looking for people who can write grant proposals to various organizations to help underwrite our efforts and remind them that - although there is ample programming for blacks, women, Hispanics and other minority groups, there is no regularly scheduled programming for Gays (possibly the largest of all minority groups!). Thanks for the encouragement!"

The Fineline and Joshua Tree/Back Pocket have requested copies of the tape of Arizona Gay to show at their bars at a time to be announced, for the benefit of those who are unable to receive the cable telecasts.

Victory In Gay Student Services v. Texas A. & M. University

NEW YORK, NY - In a major victory for the rights of Lesbian and Gay students, the Fifth Circuit Court of Appeals has held that the refusal of Texas A & M University to officially recognize a Gay student group was an infringement of the group's First Amendment Rights.

"This is a strong affirmation of the First Amendment rights of Gay men and Lesbians to gather together and to speak out about Gay civil rights at public university campuses. It is a particularly sweet victory for the students since it comes after eight years of litigation," exclaimed a jubilant Abby Rubenfeld, managing attorney for Lambda Legal Defense.

Lambda has been actively involved in the Texas case as a friend of the court on the side of the Gay students group. In the summer of 1983, to the great surprise of everyone involved, a group called "Dallas Doctors Against AIDS" also filed an amicus brief - on the side of the University.

The DDAA brief alleged that the AIDS crisis was a reason upon which to base the denial of recognition because a Gay student's group on campus constituted a public health risk. To counter DDAA's involvement, and to insure that the court understood that AIDS is not spread or transmitted by casual contact such as meeting

together - Lambda arranged to have another amicus brief submitted on behalf of the students by the American Public Health Association.

A third amicus brief on behalf of the students was submitted by the Texas Human Rights Foundation. "This case is also significant in that it represents the first time that a court has heard, and soundly rejected, the bogus claim that Gay people gathering together will pose a 'public health risk' - a precedent that will prove helpful in later cases," comments Lambda's Abby Rubenfeld.

She adds: "The language of the court's decision clearly establishes that the contrived excuses offered by the University for denying recognition, including the bogus claim of a 'public health risk', cannot overcome the fundamental constitutional rights of Gay and Lesbian Students.

The decision bodes well for another case in which Lambda is involved - *Baker v. Wade* - also pending in the Fifth Circuit Court of Appeals.

Lambda Legal Defense and Education Fund is an organization expressly concerned with fighting discrimination against Lesbians and Gay men through litigation and education.

CLOUD 9 OPENS AT TCC LITTLE THEATER SEPTEMBER 5

TUCSON - "Gay men and Lesbians love Cloud 9"...."A biting, witty, satirical farce....", "Divine Madness....", "Cloud 9 is a bundle of merry mischief-poignant characterization, malicious charm, and absurdist slapstick...."

Cloud 9, the longest running comedy on or off Broadway, comes to Tucson, September 5 at the Tucson Community Center Little Theater. The comedy is set in darkest Africa in 1880 and in present-day London. SUPERMARKETS FINALLY RECOGNIZE GAY MARKET

WASHINGTON, DC - Supermarkets must now plan to serve the Gay market, among others, to survive in the 1980's, according to the Washington-based Food Marketing Institute's Executive Vice President, Timothy Hammonds.

"Customers are fragmenting into more and more diverse groups, from Yuppies to Guppies to Hispanics to Hush Puppies. All have their own special needs," Hammonds told the Associated Press. Guppies are Gay urban professionals. The pressure to serve these groups comes in part from the rise in one and two person households and the number of households where both adults work, putting a premium on convenience at markets.

RICHARD PRYOR APOLOGIZES FOR REMARKS THAT SHOCKED GAYS

LOS ANGELES, CA - With a few hesitant and soft-spoken phrases, actor Richard Pryor apologized for the invective with which he shocked and alienated the Gay community nearly seven years ago.

The apology, which brought the audience at a Biltmore Hotel ballroom benefit to its feet with a roar of happy acknowledgement, came at the conclusion of a well-received comedy routine Pryor donated to the 11th Anniversary Dinner of the Van Ness Recovery House, a recovery program for Lesbian and Gay substance abusers.

"I went to make amends for something that happened at a human rights benefit at the Hollywood Bowl," Pryor said. "I was drunk and I was doing some coke and I was an asshole and I hurt a lot of people, and I apologize. I really don't mean those things."

Pryor's bid to "make amends" - one of the stages in recovery and self-realization for people who are part of substance-abuse programs - capped a successful three hour benefit which raised more than \$20,000 for the Van Ness House.

LITTLE WHITE LIES

NEW YORK, NY (CON) - A spokesman for New York's Catholic Archbishop John J. O'Connor has owned up to an "unfortunately misleading" report which said Pope John Paul II had given explicit encouragement to O'Connor regarding his stand on the city's Executive Order 50, according to the New York Times. (Observer, Vol 1, Issue 5).

The Rev. Peter G. Finn wrote a letter appearing in an issue of Catholic New York that, contrary to earlier reports on its pages, "O'Connor did not have a private discussion with the Holy Father," and the Pope did not "address Executive Order 50 or any other matter pertaining to the city of New York." O'Connor boasted in a previous issue that the Pope "strongly encouraged me to continue to present the position of the Church" on homosexuality. In truth, O'Connor, along with ten other newly named archbishops, attended a luncheon with the Pope during which he urged all present to "present Church teaching firmly without compromise, but gently and charitably."

O'Connor is presently embroiled in a struggle worth \$76 million in social service contracts with the city of New York over Executive Order 50. O'Connor has refused to sign the pledge requiring private groups doing business with the city to state they will not discriminate in employment or hiring because of "race, creed, color, national origin, sex, age, handicap, marital status, sexual orientation, or sexual preference." O'Connor maintains that to sign the pledge would amount to a violation of Church teaching on homosexuality.

Mayor Ed Koch is not enforcing the order while it undergoes legal challenge in the State Supreme Court in Manhattan.

AIDS MOVES BEYOND THE BORDER

Tijuana's Gay activists face an uphill road in persuading the Mexican government to acknowledge the existence of an AIDS crisis there. Among the barriers are bureaucratic convulsions in Mexico's political system, infighting between Gay groups in Tijuana, social pressures that keep most Mexican Gays in the closet, and the continuing lack of concern about AIDS from the United States Government and its representatives in international health organizations.

According to Emilio Vasquez, co-founder of the Tijuana Gay group FIGHT (Frente Internacional por las Garantías Humanas - International Front of Tijuana for Human Rights), at least four, and possibly five, people have died so far in Tijuana from AIDS. A conference on AIDS was held last month in Mexicali, also a border city in the Mexican state of Baja California, at which doctors from Mexico City gave a talk on the syndrome to local health professionals. Another conference, scheduled for Tijuana, has been postponed because of personnel changes in the local health administration.

Vasquez explains, "The head of the Seguro Social - the Mexican social security administration, which deals with public health issues - "for this has been changed. He's new, and as far as we know, he's not aware of the problem and will have to be educated."

One of the major goals of AIDS work in Mexico is to persuade the United States government to take a more responsible position toward the crisis. Vasquez claims that all eight AIDS deaths in Baja California were people who contracted the disease in the United States.

Although Tijuana has a larger population than San Diego, it has only three Gay organizations - and no Gay press except a small monthly newsletter, Y Que. Machismo prejudices against Gay men are still so strong that, according to Vasquez, most Gay men of his acquaintance also have sex with women, if only to 'prove' to themselves and others that they're not 'really' Gay.

Because most Tijuana Gay men are also involved with women - and many are married and/or have children - Vasquez expected AIDS to spread out of the Gay community in Mexico much faster than it has here. Already, one man, before dying of AIDS, got a 16-year-old pregnant; both the young woman and her baby are under doctors' observation. And another man with AIDS, said Vasquez, "was 37 years old, had lived with his family all his life, and nobody knew he was Gay until a week before he died."

When the earring is worn in the right ear, the male is making it known he prefers to play the submissive role. I am told that this code is said to be understood by homosexuals all over the world.



Where she thinks the food is "Down Home" - you think it's "Interesting" to say the least. Auntie Mae and I found just the place - it's the Blue Sahuaro.

This is a "family" run business - the cook is the owner - the hostess is the manager.

Now the food. There were no appetizers on the menu so we did not have to endure anything yet.

For dinner Auntie Mae tried the shrimp - I ordered the Lobster Tail. A friend who was with us ordered the steak and scampi. With dinner you get your usual salad (consisting of lettuce with a cherry tomato on the side), soup or beans - the soup was the best - it was French Onion (served with plenty of onions and sprinkled with croutons. The beans tasted like they came from a can. We quickly discarded these!

After a considerable wait - the food arrived - it wasn't hot! Poor Auntie. I would have sent it back, but would it be worth it?

The shrimp were heavily coated with a breading - this definitely masked the flavor of the shrimp. The lobster tail was nice and tender, served with a baked potato - not bad for \$12.95. The steak and scampi - The steak was tough and gritty, the scampi were a delight!

The Blue Sahuaro has a full bar, but not much to choose from as far as

the wine list goes.

Dessert - you have two choices Ice Cream or Sherbert. We passed on both.

In conclusion - Auntie Mae loved dinner, so that's all that matters. I would not return, at least not until next year when Auntie Mae makes her yearly visit.


