

JANUS Theatre "The Ritz" Opens Feb. 1



PHOENIX - Janus Theatre Company will present Terrence McNally's zany comedy "The Ritz" as its first production for 1985. The madcap production -- featuring the largest cast ever assembled for a Janus undertaking -- will be staged February 1 & 2; 8 & 9; 14, 15 & 16 at 8:00 p.m. In addition, there will be a matinee on Sunday, Feb. 10 at 2:00 p.m.

All performances will be at the Phoenix Arts Council Theatre, 302 W. Latham.

"The Ritz," directed by Janus' co-founder and co-executive director Steven Schemmel, concerns the comic efforts one man makes to escape his

brother-in-law, a czar of the underworld. To avoid his vengeance-seeking relative, the man ducks into the last place in New York he thinks his brother-in-law will look -- a Gay bathhouse. Once inside, he encounters a cast of strange characters and comic situations.

"The Ritz" was made into a film in the late 1970's and starred Jack Weston and Rita Moreno.

— NGTF: Do Not Take HTLV-III/LAV Test —

NEW YORK, NY - A coalition of national Gay/ Lesbian and AIDS service organizations have released a joint statement initiated by the National Gay Task Force recommending that Gay men not take the soon-to-be-licensed test for antibodies to HTLV-III/LAV, the virus believed to be associated with AIDS. The test does not diagnose AIDS or contagiousness. It merely indicates the presence of antibodies to the HTLV-III virus.

The statement emphasizes that the test should be used only in the context of screening blood donations in order to help safeguard the nation's blood supply, and as part of research programs that guarantee strict confidentiality. It also underscores the need for Gay men at risk to AIDS to continue to avoid donating blood in order to minimize the chance of any HTLV-III virus entering commercial blood products. These voluntary deferral guidelines must remain in effect because, as the statement points out, the test is not 100% effective according to present data.

If a positive antibody test becomes part of an individual's permanent medical records, potential employers interested in screening out Gay men could conceivably use the test as an indicator for homosexuality, since more than 70% of the reported cases of AIDS are Gay men. Such discrimination would be both medically and socially indefensible, but would be difficult to prevent interpretation of the law. Lesbians and Gay men are not protected from discrimination in most jurisdictions.

The Lesbian and Gay community nationwide has responded to the AIDS crisis with an outpouring of resources, as well as a lobbying effort that has resulted in increased government funding for AIDS research, and in turn such developments as the HTLV-III blood test. Now the test is about to become

commercially available, it is critical that the legitimate value of the test, as well as its limitations and risks, be thoroughly understood.

The joint statement says in part: "With the expected licensing by the U.S. Food and Drug Administration of the test for antibodies to HTLV-III/LAV, the virus considered to be associated with AIDS, it is important to state what we believe this test does and does not do, what its potential misuses are, and what risks members of the Gay community face if they take this test.

"It is our recommendation that, except in rare circumstances, this test should be used ONLY in the context of screening blood donations and as part of research programs that guarantee strict confidentiality. Individuals should be aware that this test will NOT provide answers to such questions as -- Am I healthy? Do I have AIDS? Am I a carrier of AIDS? Have I been exposed to AIDS? Can I give AIDS to someone else?

"Individuals should be aware of the fact that their test results may be requested and obtained by third parties. Before requesting a blood test under any circumstances, we urge all individuals, particularly those in the Gay community, to consider the following risks:

1. If a positive antibody test becomes part of your medical record, it could become justification for denial of life or health insurance in the future. (We are already aware of cases where individuals considered at risk to AIDS have been denied insurance.

2. A positive antibody test could also become a reason for denying employment. While lacking in medical justification, we are deeply concerned that this test will become a mechanism for screening out individuals who are at-risk to AIDS from jobs in such

Houston Voters Overkill 'Gay Rights' Ordinance By 4-1

HOUSTON, TX (AP) - Two anti-discrimination proposals, which together were dubbed the "Gay rights" ordinance, were defeated by margins of 4-1 and 5-1 amid heavy voter turnout discrimination on the basis of race, color, age, disability, sex or national origin.

Each measure lost by a margin of more than 81 percent to 18 percent. More than 239,000 people, or about 28 percent of Houston's registered voters, cast ballots.

Neither ballot issue mentioned the words "homosexual" or "Gay", but residents were asked to decide whether sexual preference should be barred as a consideration in hiring, firing and promoting city employees.

Opponents insisted that approval would grant legal status to homosexuals in the nation's fourth-largest city. Backers argued that the proposals would merely extend anti-discrimination protection.

Political analysts said before the referendum that a turnout of 30 percent of the voters would be almost three times above normal for an election to decide issues rather than candidates.

Proposition A would have barred the city from discriminating on the basis of "sexual orientation" in its hiring, promoting or firing of employees. It was rejected 198,563 to 41,706, or 81.6 percent, with all 418 precincts counted.

Proposition B - rejected 197,763 to 43,303, or 82 percent to 18 percent - would have had city policy specifically state that the city should not keep track of how many homosexuals it hires. As an affirmative action measure, the city now monitors how many women, blacks and Hispanics it hires.

No action was taken until June, when a City Council majority, including Mayor Kathy Whitmire, narrowly approved Hall's idea. Opponents quickly gathered more than 60,000 signatures on petitions, forcing the council either to rescind its vote or call an election.

The Council opted for the election, an expense of some \$300,000.

Houston's Gay population has been reported at times as the nation's second largest, after San Francisco, where 15 percent of the 700,000 are Gay. However, experts say they have no way of estimating how many homosexuals live in Houston or work for the city government.

Analysts said the outcome of the vote would indicate larger trends in Houston's political power structure, now split between old-line conservatives, including much of the city's business community, and a liberal faction led by Whitmire.

"If there's ever an issue to mobilize that constituency, this is it," said Richard Murray, a political analyst at the University of Houston. "It will tell us something about power in the city."

Whitmire, the city's first mayoral candidate to be endorsed by Gay groups, received strong Gay support in her two successful elections. She has been the most prominent backer of the proposals.

"The only issue here is whether or not people should be denied a job," she said.

The Rev. Bill Oliver, a civil rights activist working for the proposals, also insists the question is not one of Gay rights. "It's clearly about job discrimination in public employment," he said.

"This is not just a discrimination against homosexuals, it reaches across the board. It affects every man who lives with a woman, every woman who lives with a man, every man who lives with a man and every woman who lives with a woman," said Jeff Sterman, spokesperson for the Gay political caucus of Houston.

The opponents included an unlikely alliance of such diverse groups as the predominantly black Concerned Pastors and Ministers of Houston, the Ku Klux Klan and the Houston Chamber of Commerce.

The chamber said passage would grant special status to homosexuals and hurt the city's image.

"Current city administrative policy provides adequate employment protection and privileges to individuals and minority groups as defined within present state and federal law," the chamber said.

Black ministers objected to the creation of a new minority group. "Nobody yet has come up with any factual information about discrimination in jobs," said the Rev. C. Anderson Davis of Concerned Pastors and Ministers.

The Houston Chronicle, recommending that voters reject the proposals, agreed with Davis, saying in an editorial last week that the election was a "classic case of solving a problem that didn't exist, of fixing something that wasn't broke."

The Houston Post called the election "needless and nasty... a ridiculous, embarrassing time for Houston."

It's a jungle out there so please be careful. Report any harassment to Jack Stockslager who is acting as Police Liaison with the Gay Community. Report any violence to the police as well as Stockslager. Don't remain quiet.

GAY GAMES NAMES NEW EXEC

SAN FRANCISCO, CA — With Gay Games II scheduled for August 1986, San Francisco Arts and Athletics has named Shawn P. Kelly executive director. Kelly having served as assistant director since November 1983, replaces Dr. Thomas Waddell, who became president of the board of directors earlier this year.

Noting that the International Olympics in Los Angeles this year saw 8000 athletes participate, Kelly said he looked forward to 5000 participants in Gay Games II. "We are well aware of the magnitude of the event that we are organizing," he said. In 1982, 1300 people from 12 countries took part in Gay Games I.

FIRST DESERT STATES

LESBIAN AND GAY CONFERENCE LAS VEGAS, NV — "Empowering One Another" is the theme for the first Desert States Lesbian and Gay Conference to be held on March 30 and 31 on the University of Nevada/Las Vegas campus.

The issue of isolation — geographical, social, interpersonal — will be the topic of workshops led by activists from each state participating in this five state conference. One strand of workshops addresses issues of personal isolation: coming out, AIDS, alcoholism in the Gay and Lesbian culture, spirituality. The second strand offers topics concerning political isolation: successful use of the media, legal issues, computers in grassroots organizing, fundraising.

In a Sunday morning plenary session, conference participants will consider a series of resolutions present to the law makers in their respective state, county and local governments. Conference planners intend to consider the formation of a five-state organization (Arizona, Colorado, New Mexico, Nevada, Utah) which would play a role in national Gay and Lesbian politics in addition to organizing efforts on the East and West coasts.

Virginia Apuzzo, executive Director of the National Gay Task Force, is scheduled as conference keynote speaker. One facet of empowerment is networking and dialogue with national homophile organizations. Apuzzo's presence at the conference is seen as a necessary step in establishing a coalition internally among the five-state bloc and in the bloc's relation to national politics.

Finally, one last word for Pooh Bear of the Arizona Rangers - the way you were carrying on this weekend you could fill up a complete page of this paper.





Well, I survived another weekend in Phoenix. As always, on good will bar runs, there were a lot of trips from one bar to the next. You really just get settled when it is time to move on.



to work together towards development and passage of an anti-discrimination ordinance in Pima County.
