Apuzzo Resigns NGTF Post To Return To Government Service



NEW YORK, NY - The Board of Directors of the National Gay Task Force (NGTF) have announced that Virginia M. Apuzzo, Executive Director of NGTF, will be leaving the organization in mid-April to assume a position in New York State government.

In announcing Apuzzo's resignation, Board Co-Chairs Frances Hanckel and Paul Vandenberg said, "Ginny Apuzzo has worked tirelessly for two and a half years, strengthening NGTF and representing the Lesbian and Gay community nationwide as NGTF's chief spokesperson. Her record of accomplishments is unparalleled. While we will miss her daily leadership, she leaves NGTF more effective than ever, with ongoing programs of proven success, administered by highly dedicated and professional people."

Added Vandenberg and Hanckel, "We are delighted that Ginny has the opportunity to do something that is both good for herself and valuable to our

community. Her return to government is a logical extension of a career that has been devoted to public service and education."

The Board will shortly begin a nationwide search for a new Executive Director. To assure an orderly transition, Jeffrey Levi, NGTF's Washington Representative, will serve as Acting Executive Director after Apuzzo's departure, until a permanent successor is chosen.

Apuzzo said that personal family concerns had played a considerable role in her decision to accept a position in Albany at this time. "I am convinced that the staff and programs in place at NGTF will assure that the organization remains the most articulate voice for Gay and Lesbian Americans," she asserted. "I pledge to find every opportunity to further the success of NGTF, and I ask my colleagues and friends throughout the Gay and Lesbian community to do the same."

Teen Love Defendant Acquitted In Minneapolis

MINNEAPOLIS, MN (OCH) - William Harren, a former dance instructor at the Minneapolis Children's Theater, has been acquitted of having sex with a 15-year-old male student.

During the trial, the young man, now 16, testified that he first told agents of the Minnesota Bureau of Criminal Apprehension (BCA) he had nothing to contribute to the investigation. "I honestly believed I had nothing to tell them," he said. "My relationship was healthy and productive. I did nothing wrong. They asked me if I had contact with a teacher. I didn't consider him a teacher. I considered him an ex-lover." He said pressure from his family, the BCA and friends finally made him reveal the relationship.

Harren testified that the youth was a student in his dance class during a 1983 summer program at the Theater. The next time he saw him was at a Gay bar in Minneapolis in mid-November. The young man was in full drag, looking like Marilyn Monroe. He asked Harren to dance and Harren accepted.

Harren next began receiving messages on his telephone answering machine from the youth who said he was desperate about his life and wanted to talk to him. Harren said he cared a lot about the young man and that the youth told him he was 17. Harren broke off the relationship after three weeks when he discovered the youth's real

age. Under Minnesota law, not knowing the age of the partner is a defense against charges of having sex with persons under sixteen.

Three witnesses testified that they had seen the youth at a downtown Gay bar in 1983. Nicholas Novak, who had gone to the bar with him, testified that he looked old enough to get in without identification and that he had first told Novak he was eighteen and later seventeen.

Also entered into evidence was testimony from Scott Creeger, a science teacher at the Children's Theater School. He reported that the youth had told him he was an accomplished con artist. He also said that the young man had problems with drugs and alcohol.

Creeger and Wayne Jennings, the school's education director, had earlier been indicted by a grand jury for failure to report suspected sexual abuse. Judge Charles A. Potter threw out those indictments on the grounds that the state's reporting statute is unconstitutionally vague.

Judge Potter acquitted Harren, who waived his right to a jury trial, about forty minutes after the close of the trial. Harren, who is now a member of the Minnesota Jazz Dance Company and a choreographer for the company, burst into tears when the verdict was announced.

NGTF To Lobby For Increased Levels

WASHINGTON, DC - The Reagan Administration's fiscal year 1986 budget, presented to Congress on February 4, includes a \$10 million cut in the Public Health Service's AIDS efforts as well as massive cuts in Medicaid and elimination of revenue sharing -- all important components of the fight against AIDS.

Commenting on the budget figures, Virginia M. Apuzzo, Executive Director of the National Gay Task Force, said, "It is incredible that an Administration that considers AIDS to be its 'number one priority' would reduce spending when we are still a long way from a cure and while the costs associated with AIDS are skyrocketing."

"Once again," Apuzzo continued, "the Administration is relying on the Congress to propose an adequate level of funding to deal with research, education and health care costs associated with AIDS. NGTF will continue its full-scale lobbying effort, in cooperation with the FARO AIDS Action Council and other groups, to obtain sufficient funds in fiscal year 1986 and supplemental funds for 1985.

The administration proposal calls for a total of \$85.5 million in AIDS-related programs for the Public Health Service in FY 1986, down from \$96 million in 1985. The budget proposal does not reflect a federal program announced last week for alternative sites for the HTLV-III antibody test. It is not clear whether those funds will come out of existing programs or whether supplemental monies for FY 1985 will be requested. The 1986 budget calls for a general reduction in the number of research grants given by the National Institutes of Health (NIH) from 8,500 to 5,000. It is not known if NGTF's lobbying efforts will seek full funding of the research needs of the Public Health Service, significant increases in the funds allocated for public education and prevention of AIDS, and restoration of cuts in Medicaid and revenue sharing.

VIOLENCE AGAINST GAYS RISES

SAN FRANCISCO, CA - Violence directed against Lesbians and Gay men in San Francisco rose significantly during 1984, according to a report by Community United Against Violence (CUAV). Figures for the first nine months of 1984 reported in the San Francisco Sentinel, showed a 16 percent increase in reported attacks over the same period in 1983. There was a 23 percent increase for the third quarter.

Another disturbing trend noted by CUAV was the steady rise in the involvement of young people in anti-Gay attacks - 36 percent in 1983 versus 48 percent during the first three months of 1984. Not only was there an increase in attacks, but they were increasingly violent. Attacks involving weapons were up by 43 percent and the number requiring medical treatment increased by 38 percent. Attacks were reported to CUAV at the rate of nearly one a day. Seventy nine percent of the victims identified themselves as Gay men, 13 percent as Lesbians and seven percent as non-Gay.

BYE BYE BOOM BOOM

SAN FRANCISCO, CA (GCN) - The most blessed Sister Boom Boom, founder of San Francisco's Sisters of Perpetual Indulgence, is leaving the nunnery and reclaiming his lay name, Jack Fertig, according to the Philadelphia Gay News. Boom Boom insists his role in a Euripides play and his career as a professional astrologer leave no time for prayer, etc. He does intend to continue fundraising to fight AIDS. The Sisters have already collected thousands of dollars toward fighting the disease.



THE BILL IS BACK

WASHINGTON, DC (CNN) - Lesbian and Gay civil rights legislation, identical to that introduced during the last Congress, was reintroduced in the House of Representatives. The bill would amend existing statutes to include sexual preference in the list of protected categories of people in employment, housing, federally funded programs and access to public facilities.

Representatives Ted Weiss (D-NY) and Henry Waxman (D-CA) are the bill's chief sponsors, and a total of 46 representatives have signed on as original co-sponsors. Rep. Morris Udall (D-Arizona) is one of the co-sponsors of the bill. Negotiations are currently underway to draft a chief sponsor for the Senate version of the bill.

LONG OVERDUE

SACRAMENTO, CA (CNN) - A man who says he was harassed out of his job as a prison guard after officials learned he was Gay has been awarded nearly \$25,000 in damages from the State Department of Corrections, according to the Sacramento Bee. Department officials have also agreed to issue a policy statement asserting the department's commitment to non-discrimination against Lesbians and Gay men.

Gerald LeFevre, 32, said his troubles began in mid-1982 after corrections officials learned he had been a victim of an assault and attempted robbery involving a suspect LeFevre met in a Gay bar in Santa Cruz. LeFevre said his supervisors ordered agents of the department's special services unit to conduct an investigation into his background and off-duty lifestyle.

At that point, LeFevre identified himself as a homosexual and was then interrogated several times by agents who "made it seem that I was the criminal instead of the victim" in the Santa Cruz incident.

"They also had agents following me, staking out my house, checking into

my private life," LeFevre said. "They interviewed former employers, they interviewed my friends, they interviewed people who came by my house, they interviewed all the parolees that had been in my charge when I was a parole officer.

Then they doubled my workload to where it was almost impossible to get my job done. Finally after almost three months of that harassment, I transferred to a job with another [state] agency."

Under terms of the settlement, LeFevre will receive \$24,710.50 in damages and the department has agreed "to provide training statewide to all its managers and supervisors on how to develop and maintain a work environment that is free of discrimination - with an emphasis on sexual orientation."

A deputy attorney general working on the case said the department's agreement to train employees to become sensitive about sexual preference was "long overdue".

APPEALS COURT RULES FOR LISTS TURNOVER

SAN FRANCISCO, CA - The U.S. Court of Appeals here recently ruled that Washington state can demand a membership list from a private Gay club when that club applies for a liquor license. The case stemmed from the refusal of a Seattle Club, The Sanctuary, to turn over its membership lists on the grounds that to do so would expose club members to harassment. The court said the club owners had failed to show that giving up the list would stop persons from "freely associating".

This decision may further complicate the efforts of San Francisco bathhouses to remain open while protecting the privacy of their patrons. According to a report in Edge, a Los Angeles Gay paper, legal fees are expected to exceed \$1 million, prompting the board of directors of the Association of Independent Gay Health Clubs (AIGHC) to ask its 38 member clubs to charge customers a temporary 50-cent surcharge to help build a fund to pay legal fees for the San Francisco clubs.

ANTI-PORN BILL DIES

SUFFOLK COUNTY, LONG ISLAND, NY (CNN) - A Minneapolis-style anti-porn bill which would allow individuals to sue the makers, sellers, distributors, or exhibitors of pornography went down to defeat in the Suffolk County Legislature. Legislators rejected the bill by a vote of nine to eight.

A November 19 federal court decision striking down similar legislation in Indianapolis figured in the defeat of conservative legislator Michael D'Andre's "Local Law To Limit Violence Against Women". (Observer, Jan. 9, 1985). The bill's introduction brought to a boil a simmering debate among feminists, concerning the so-called civil rights approach to regulation of pornography.

Several legislators said they doubted the bill would withstand legal challenges, and a legislative aide to D'Andre told CNN that the Indianapolis ruling had cast a shadow over the Suffolk County bill. Arnold Reisinger, D'Andre's aide, indicated that his boss would wait until the legal appeals surrounding the Indianapolis bill were resolved before he would consider re-introducing his own version. "Why should we pay all the legal expenses?" Reisinger asked. "Let's see what happens and then we may re-activate the bill."

FIRST IN MAINE

PORTLAND, ME (CNN) - A 31-year-old Gay man from Portland has been diagnosed with AIDS, the first case reported to the state health officials in Maine, according to the Boston Globe. "This is our first diagnosed indigenous case which meets the Centers for Disease Control criteria [for AIDS]," said James Novotny, director of the state's Sexually Transmitted Disease Program.

The four states that still have not reported cases of AIDS are North Dakota, South Dakota, Idaho and Montana. State officials in Maine expect to see several additional AIDS diagnoses in the months ahead.

GAY HEALTH

Dear Readers: The Centers for Disease Control have called on the public to use the new hepatitis vaccine. You may recall my reporting to you that two-thirds of U.S. doctors who are candidates for the hepatitis vaccine have rejected that latest immunization, largely because of their fear that because it is the first vaccine ever prepared from human blood, it may contain the agent responsible for transmitting AIDS.

Now, thanks to a Canadian reader, I can report that Canadian doctors are no different than those in the United States. According to the Canada Diseases Weekly Report of last September 29, the staffers at Toronto General Hospital who were considered to be at risk were offered the hepatitis vaccine at no cost to the individuals. Of 700 persons in this high-risk group, only 37 percent were willing to take the vaccine.

Thus, we now know that, even though not one single case of AIDS ever has been traced back to the hepatitis vaccine, Canadian health personnel are just as frightened of it as their U.S. counterparts are.

An interesting finding in this study was a very low seroconversion rate. This means that many of the vaccine recipients failed to show evidence in blood tests of immunity from the vaccine. The researchers can't put their fingers on the reasons for this, but they are considering the possibilities of errors in storage of the vaccine, even though laboratory studies conducted on samples that were returned from the study showed that the

vaccine had maintained its potency. The Toronto researchers concluded that "this study demonstrated that the vaccine was not as immunogenic as anticipated."

If you or any member of your family or close friends is advised to take the hepatitis vaccine, in view of the above information, you now have three choices:

1. You may refuse it.
2. You may accept it only to learn later that it didn't work.
3. You may be one of the lucky ones whose blood tests show evidence of immunity and who has suffered no damage from this latest "advance" in medicine.

TO THE EDITOR:

I buried my youngest son last summer. He died of AIDS. He was neither a homosexual nor a drug user. In spite of the impression given by Ed Asner in the TV special he narrated on the subject. In that program, he claimed that these are the two main groups of people affected by and mainly responsible for the rapid spread of AIDS as a consequence of their lifestyle - a lifestyle they can choose.

But my son had no choice. He was born a hemophiliac and had to use the blood-clotting Factor VIII all his life to control the bleeds he suffered constantly in his joints. One of the donated pints of blood used for one batch of Factor VIII was contaminated with AIDS. The incubation period for this disease can be anywhere from a month to two years, so I don't even know when my son received the contaminated infusion of Factor VIII.

Statistics quoted in the TV film say that only one percent of hemophiliacs are affected so far, but believe me, it is one hundred percent when you watch your much-loved son, who has already suffered a life of pain and emotional trauma, lie there dying in misery.

For the last few months, I have lived in a numb void, unable to truly grieve for my son because I was so angry at a group of people (homosexuals) who had dared to donate to blood banks and contaminate the nation's blood supply. But I couldn't really be angry with other mothers' sons, who are also suffering and dying in far larger numbers than any other segment of the

population. So I tried to discover what was being done in the medical community to halt the spread of AIDS.

I purchased a book called "AIDS: Everything You Need To Know About Immune Deficiency Syndrome" by Janet Baker, so that I might better understand what happened to my son. She points out, in chapter XIII, that as of January 1983, "...Congress has given a total of \$2 million to the Centers for Disease Control in Atlanta to study AIDS. More people have died of this disease in 18 months than the deaths from Legionella and Toxic Shock Syndrome combined. Yet, seven times the amount of money was spent by the government on each of these diseases." Baker claims that the social unacceptability of the group of people hardest hit by this epidemic is the reason for the politically expedient decision to spend little money on a search for its cure. She quotes Congressman Henry A. Waxman, Chairman of the Subcommittee on Health and the Environment: "There is no doubt in my mind that if the same disease had appeared among Americans of Norwegian descent, or among tennis players, rather than among Gay males, the response of both the government and the medical community would have been different."


After reading this book, my anger has a definite direction. How dare any politician interfere with money for research that could affect the health of our entire nation. These, our duly elected servants, are sworn to uphold the Constitution and protect the rights

of lifestyles may be. And homosexuals, drug users, Gay militants and homophiles are all United States citizens. When their health is threatened by an epidemic which also shows possibilities of affecting the entire nation, we don't need political games to be played. The money needs to be spent now.

Why am I writing this letter? It won't bring my son back; it is over for him. He is past all further pain and suffering. I write because I have another son - also a hemophiliac - who saw his youngest brother die. He is so scared of dying like his brother that he is trying to live without treating the bleeds he has, thus doing more damage to joints already badly injured. His future holds certain disability or death unless something is done quickly.

The number of AIDS victims is doubling every six months. How long are we going to count the cost and allow the government to drag its feet before we make an all-out effort to find a cure? The very least that could be done is to implement the blood-screening technique that is available already but which, due to cost again, is being used in only eight blood banks around the country. This would at least avert the inadvertent transmission of AIDS to unsuspecting hemophiliacs or surgical patients, but it still does not treat the much larger problem, already of epidemic proportions, of finding a cure for this deadly disease.



TAX TIPS

WHO IS US! WHO IS US!

In nearly twenty-five years of tax practice I have never seen the tax laws changed in as restrictive a manner against the taxpayer as the recent changes that have been enacted in the past year. Furthermore, my analysis of recent Treasury and Congressional committee proposals indicates that the worst is yet to come. The individual taxpayer most adversely affected will be those who can least afford it. Only the taxpayers with the simplest of returns will escape the wrath of the new tax laws.

Sorry to begin in such a gloomy fashion, but the tax season is here again. April 15th will be here before you know it! So get busy now. The final day rolls around in short order.

Every year at this time a number of new clients consult with me and ask me what they should do to lower their taxes. Now is too late. Now the tax preparer can only do the best with the facts as they have already taken place. Those of you with larger than average incomes should consult your tax preparer before the end of the tax year. Very often, your professional advisor can assist you in lowering your tax bill substantially. Very often it only takes proper timing of fiscal events on your part to lower your taxes.

Tax indexing took effect for the first time in January. This means that your federal tax withheld decreased based on last year's rate of inflation. Since last year's rate was a modest 4% the decrease in your taxes is moderate. But hold on, the social security tax went up this year from 6.7% to 7.05%. The net effect on your paycheck will just about even out to nothing for the average taxpayer. I just thought you might like to know why your check amount changed slightly.

If you contribute to an IRA plan, an important change has taken place. In 1984 you could contribute as late as October 15th (with proper extensions) to your IRA plan for the 1983 deduction. This has been changed. In 1985 you have only until April 15th to contribute to your IRA plan for the 1984 deduction. This is true no matter what extensions of time you receive for filing your return.

A small, but very important point about IRA's is often overlooked by many people. All the advertising you read about IRA's always stresses the \$2,000 maximum limit. Sometimes when I advise a client to begin an IRA, the response is I never have \$2,000 at one time, so I can't do it. Horsefeathers! IRA accounts can be opened with an opening deposit of \$250 with later additions of as little as \$100 at a time. Remember, even a partial IRA is better than no IRA at all. I have a number of satisfied clients who began with small IRA's and now they have tidy little sums put away.

Income averaging has been hardest hit by the recent changes in the tax law. The new base for income averaging now consists of an average of the previous three years instead of the

previous four years under the former law. This tends to push your average up and reduce the amount eligible for averaging. In addition, in order to qualify for income averaging the current year's income must exceed the average of the base years by at least 140% plus \$3,000 instead of 120% plus \$3,000. For example, if your average taxable income for 1981, 1982 and 1983 was \$20,000, you would need 140% of that or \$28,000 plus \$3,000 for a total of \$31,000 of taxable income in 1984 to be eligible for income averaging. Even then only the amount of taxable income in excess of the \$31,000 is the amount eligible for averaging.



A View From Within

YOU MAY ASK, "JUST WHO THE HELL DO I THINK I AM?"

Dear Readers:

May I begin by thanking all of you, my readers, for your kind comments and wonderful support since I began writing my column in September 1984. I am just a poor soul who has something to say to just about anyone who cares to listen. True, I once had a successful career as a fashion designer in California. The host of a television show in 1984 introduced me as an up-and-coming premiere fashion designer in Northern California. Pretty heady stuff. There came a time, though, a few days before my birthday in July 1984, when I suddenly realized that hundreds of innocent men and women were being murdered because they were Gay. Many of these occurring in my home town of San Francisco.

Well, that was heady stuff. For some time, I have been very proud of the fact that I am Gay. I have made quite a turn-around since the time when I tried to kill myself because I hated being Gay. I have helped friends come to terms with the fact that they are Gay. One particular friend said, after a marathon talk session in the parking lot outside my favorite dance club, that I ought to go into politics. Oh sure, I thought, see me "Mr. Senator". Well, one thing has led to another and here I am writing about my thoughts, my life and my opinion.

Why do I write about these things? When I came out in San Francisco, October 12th, Sunday morning, 1980, I realized how stupid being closeted was. All of the torment, pain, suffering while growing up in Phoenix. It was a torture that I wouldn't wish upon my worst enemy. I only wish that there was a column like mine for me to read when I was growing up Gay.

(The circle closes the pattern begins again.) I write about the things that happen to me, because they have happened or will happen to you, write about how cheap it feels to be used in a one-night-stand because I want to tell you something I wish someone had told me. ("The Glory of a One Night Stand" 28 November 1984) Yes, the realization hurts, but life is like that. It hurts even more when I write and re-write my columns because I have to relive those events all over again. I write about the alternatives to drinking and drugs because I have seen too many good people destroyed by them. ("Booze and Pills: Go Ahead. Kill Yourself" 27 December 1984). I write about my relationships with men because I want everyone to know that there is hope. ("When I Tell You I Love You" 23 January 1985) I have been hurt far too

often by my past relationships with men to ever feel I could love again. I have become jaded, hard and bitter. However, my experiences are just like many of yours: All the pain, all the emptiness, all the loneliness, and all of the love.

I am really no one special. I have no credentials to be a writer. If I wrote up a resume for a job as a writer, my only qualification would be "HAVE LIVED LIFE FOR 25 YEARS: Nothing else, nothing special.

AN UPDATE: Ty and I are still together. Thank you all who have wished us well. I am growing so much as a person because of Ty.

When I was treated so poorly by my boyfriends in the past, I began to build a wall around me, so that no one would ever hurt me again. Ty is such a special person that he is beginning to take down that wall one brick at a time. He is teaching me how to love again, and that it is okay to trust someone in an intimate way again. More importantly, Ty is teaching me that it is okay to allow someone else to love me. That it is okay to allow someone in that close to me. The whole experience is frightening, but I am being challenged to grow.

The hardest thing about this relationship occurred Friday night, 2 Feb. 85. It was then that I realized that I was in love with Ty. To see this sentence in the cold, hard type on the clean, virgin white paper makes the whole thing seem distant. It is not. I felt in my heart that I would never love again, and yet it has happened. It has been almost three years since I loved last. It has been too long. Too long.

I am very happy that my suicide attempt in 1979 failed. As bleak and awful as my life seemed then, it has brought me my life now, my achievements, and Ty.

I will continue to write about my life only as long as I continue to live and experience it. As long as I am affected by the world around me. As long as I can cry (like at Bette Davis dying in *Dark Victory*), as long as I can cheer and feel pride in my country (as with the Olympics this past summer), and as long as I can feel love in my heart I will know that I am alive. As long as I know I am alive, I will write.

As long as I am a Gay-American, and proud of both, you can read me here, same place, each week.

Post Script: Happy Valentine's Day Ty. Thank you.
