## Supreme Court Hears Case Against Gay Teachers

WASHINGTON, DC (OCN) - In a crowded courtroom full of anxious observers, the U.S. Supreme Court heard oral arguments on January 14, in a crucial First Amendment case, the outcome of which will profoundly affect both future Gay rights legislation and the free speech rights of public employees.

At issue in Oklahoma City Board of Education v. National Gay Task Force (NGTF) is the constitutionality of an Oklahoma law authorizing the dismissal, suspension or denial of employment to any teacher, student teacher or teacher's aide who speaks out in favor of "public or private homosexual activities or conduct."

Enacted in early 1978, on the heels of Anita Bryant's Save Our Children from Homosexuality Crusade, the Oklahoma law is almost identical to the Briggs' Initiative, a California referendum which voters overwhelmingly defeated in late 1978 after a massive grassroots educational effort by Gay and Lesbian activists. Bryant, a former Miss Oklahoma, urged the law be passed in a speech to the Oklahoma Senate in which she appealed to them to help stop "the flaunting of homosexuality."

The law, Oklahoma Statute Title 70, Section 60-103.15, allows the firing of a teacher for public Gay sex

or "public homosexual conduct." In the pivotal provision of the law, public homosexual conduct is defined to mean "advocating, soliciting, imposing, encouraging or promoting public or private homosexual activity in a manner that creates a substantial risk that such conduct will come to the attention of school children or school employees."

Under the law, a non-Gay person can commit public homosexual conduct. As written, the law applies even if the speech at issue takes place off school grounds, during or outside classroom hours, in public or in private, and even outside the hearing of a child or school employee.

There is no exclusive provision in the law requiring that a queer nexus be established between the pro-Gay speech and a teacher's ability to teach. Instead, the Board considers four vague "factors" in making a determination of a teacher's fitness: "the likelihood that the activity or conduct may adversely affect students or school employees; the proximity in time or place between the conduct to the [employee's] official duties; any extenuating or aggravating circumstances; and whether the conduct ... is, of a repeated or continuing nature which tends to encourage or

dispose school children towards similar conduct."

NGTF Executive Director Ginny Apuzzo recalled that her organization brought the lawsuit after two teachers originally intended to sue withdrew their names - a dramatic example of the "chilling effect" repressive legislation can have.

The case was decided at the district court level on NGTF's motion for summary judgment upon the stipulation (the agreement) by both parties that there was no genuine issue as to any material fact. Summary judgment is a procedural shortcut that allows a court to decide a case as a matter of law, simply on the pleadings and without the taking of any evidence.

The district court upheld the statute in an unpublished opinion in 1982. NGTF attorney William Rogers of Oklahoma appealed the case to the Tenth Circuit Court and won a partial but important reversal. Noting Oklahoma's sodomy statute, which punishes the "depicable and abominable crime against nature" with a ten-year prison term, the circuit court upheld the law with respect to its ban on public homosexual activity by teachers.

The court also upheld language in the law prohibiting the "soliciting or imposing" of public or private homosexual activity, but found the anti-advocacy provision to be too broad under the First Amendment and deleted from the statute the clause banning the "advocating ... promoting or encouraging" of public or private homosexual activities.

At the oral arguments, the Board of Education attorney, Arrow, argued that in fact the law only barred advocacy that urged students to commit homosexual acts. When Justice William Brennan asked if the law could be used against teachers who said, "I wish they'd leave these homosexuals alone," Arrow answered no, and argued that as a matter of judicial interpretation, the state court would find such a broad statement to be protected.

Arrow raised four main arguments in support of the law. First he argued that the state has a legitimate right to promote student respect for the law and to prevent corruption of student morality. Second he argued that teachers are strong role models for children, and the state has an interest in assuring that its teachers will be models who will promote "normal ... social integration."

Third, he argued that free speech rights of public employees differ from those of private citizens, and that the state can properly regulate "the manner in which public school teachers advocate the crime of homosexuality." And finally, he argued that despite separate laws that allow the firing of a teacher for immorality or moral turpitude, the anti-advocacy position fills a big gap in state law that would otherwise preclude dismissal of unfit teachers.

Laurence Tribe, a noted constitutional scholar from Harvard University, argued the case for NGTF, assisted by Kathleen Sullivan. Tribe raised three major arguments: that the law was an unconstitutional attempt by the state to regulate speech based on its content; that the law had an enormous chilling effect on Oklahoma teachers; and that the law did not serve any "legitimate state interest in preventing the incitement of criminal activity or disruption of the education of children in the public school."

The justices seemed quite engaged by the arguments and had more questions for Tribe than Arrow, a fact that knowledgeable court wags say means nothing. Chief Justice Warren Burger, with typical insight, noted that the state could certainly proscribe

teachers' advocacy of drug dealing or murder.

Tribe countered that under the First Amendment the state cannot punish the advocacy of reform of criminal law, nor regulate the content of expression with which it disagrees. When Tribe noted that the First Amendment upholds the right of citizens to speak out in favor of even the violent overthrow of the government, Burger responded, "If you advocate the violent overthrow of the government in this country or any other, you get shot."

Justice William Rehnquist observed that the law had not been applied in any teacher's dismissal and asked what was the harm in the law. Tribe pointed out the law's chilling effect on speech as a continuing harm endured by the teachers NGTF represents.

Justice Thurgood Marshall noted that the legislature is allowed to take into account that teachers are role models for students, to which Tribe countered, "If teachers had the strong and penultimate power as role models, one would expect there to be no Gay people."

The scope of the arguments was unnerving, because it dramatically showed how foreign the reality of Gay life is to members of the court. The Chief Justice lumped Gay people in the same breath as heroin dealers and murderers; Justice Rehnquist spoke about how no actual harm has been done by the statute. Justice Sandra Day O'Connor asked why the state doesn't have the right to have its way. As Apuzzo observed, "It was horrifying to listen to that stuff."

Apuzzo identified another lesson the argument holds for the Gay and Lesbian community: "Gay people and Gay issues don't have judicial access, because judicial access presupposes the right of the person to be there. What Gay people have to do each time we're in court is to plead for the right to be there."

### McBride Will Ruled Valid

ERIE COUNTY, PA - On January 4, Judge B. Dwyer of Erie County, Pennsylvania ruled that the will of John D. McBride was properly executed. McBride, a native of Erie, Pa., died in Mexico on May 20, 1983. (Observer, Issue 2). This decision is an important statement to the Lesbian and Gay community about our control over our property and money. In his will, McBride left assets in excess of \$100,000 to be used to further Gay civil rights. McBride was survived by two nieces. One resides in Shattuck, Oklahoma, and one lives in Wilmington, North Carolina. The two nieces filed a petition with the Court challenging the will on the following grounds:

1. That Mr. McBride, at the time of the execution of his will and at the time of his death, was domiciled in Mexico, and that, under the applicable laws of Mexico, his will was not properly executed; and
2. that on the date of January 5, 1981, when Mr. McBride signed his will his mental and physical condition was greatly impaired and that he was not of sound mind and was incapable of disposing of his estate.

But Judge Dwyer, in a victory for Gay people everywhere ruled that, "there may be many people who would disagree with the propriety of such distribution, but, since a testator has a right to dispose of his property in any manner that is not illegal or against public policy, such disposition must be allowed."

"It is the opinion of this Court that decedent's obvious intentions were that his property located in Erie County, Penn., be disposed of under the probated Will. Since the probated Will

## MACROBIOTICS, ACUPUNCTURE SUGGESTED AS AIDS TREATMENT

NEW YORK, NY - Macrobiotics and acupuncture are now among the therapies being investigated to help prevent or relieve AIDS symptoms.

At a recent forum held here, Michio Kushi, an author and leading advocate of macrobiotics, said the blood purifying and balancing effects of macrobiotic eating could help prevent the worsening of, and sometimes reverse AIDS symptoms; and prevent malignancies and infections which AIDS patients are highly susceptible. Dr. Martha Cottrell and Dr. Ronald Hoffman, New York physicians, spoke about encouraging results they are witnessing with patients who are incorporating macrobiotics in their lives. The results are part of a research project on macrobiotics and AIDS begun about nine months ago in collaboration with Boston University Medical School. However, they emphasized that it is too early to make definitive statements.

At New York City's Lincoln Hospital, Dr. Michael Smith says he has used acupuncture on more than 30 patients with AIDS. As reported in Sacramento's Gay monthly, Pallas, Dr. Smith says that, in one patient, symptoms (night sweats and extreme fatigue) disappeared. In another, the spread of Kaposi's sarcoma appears to have been arrested. Dr. Smith is applying to the New York state AIDS Institute for a grant to thoroughly evaluate acupuncture as a treatment for AIDS.

TUCSON - On February 14, at 9:00 p.m., the phone lines will be open and "Arizona Gay", a weekly forum about being Gay in a straight society, will be cablecast live from the Tucson Community Cable Corporation's studios over Cox Cable's Channel 37.

Guests will be available to discuss all aspects of Gay and Lesbian perspectives and problems. Callers will be invited to ask questions or offer comments on the show and the programs it has presented thus far.

"I really have no idea what to expect," says the show's producer, James Farias. "It's an experiment and we want to get some feedback from our viewers. Perhaps the anonymity of a telephone line will encourage people to contact us who would otherwise have not written or come on the show. I just hope we get some callers."

meets all the requirements of 20 Pa. C.S.A. 2504.1, this Court will hold that the execution of same under Pennsylvania law is valid."

It was the wish of Mr. McBride that Dr. Raymond Lemieux be the residuary beneficiary for the estate, and in conjunction with the publisher of the Advocate, David Goodstein, he will determine how the money will be distributed.

According to James Marsh, attorney for the trustee, McBride's nieces have the right to appeal Judge Dwyer's decision to the Superior Court of Pennsylvania within 30 days.

Mr. McBride's wish was that the bulk of his estate be used "in the furthering of civil rights of American homosexuals and to aid and assist those homosexuals who have been the victims of legal duress and also in furthering in the courts and in the United States Congress abolition of restrictions of any kind or nature against the civil rights of homosexuals."

HOLLYWOOD, CA - Comedienne Joan Rivers received an unexpected serenade from the Gay Men's Chorus of Los Angeles while promoting her book "The Life and Hard Times Of Heidi Abramowitz". Scheduled to dedicate a special Walk of Fame star to the fictional character with a notorious sexual history at the Travel Lodge on Sunset Boulevard, Rivers was posing in front of the unofficial memorial four-poster bed in the motel's parking lot when, from the second story balcony directly above her, the Gay Men's Chorus appeared singing a variation of the Hallelujah Chorus.

Recovering from the surprise, Rivers quipped, "These guys and my husband Edgar, are the only men I know who haven't slept with Heidi."

SANTA ANA, CA (CCN) - A blood drive to collect donations from Lesbians was cancelled by a Red Cross official here because he feared the consequences of publicity identifying the drive's sponsor as the Gay and Lesbian Community Services Center of Orange County.

Dr. Benjamin Spindler told CCN that publicity which announced a "Gay and Lesbian blood drive" would damage the reputation of the Orange County Red Cross and cause the public to question whether Spindler could adequately protect the blood supply from contamination by HTLV-III, the virus suspected of causing AIDS. Spindler is director of the Orange County Red Cross blood services.

We need your help and support. Numerous problem areas facing Lesbians and Gays in Tucson have been brought to my attention. Everyone wants something done as soon as possible to fix all these problems.

The Tucson Lesbian and Gay Pride Committee would be more than willing to take care of these problems but we don't have enough people willing to volunteer their time and energy.

Believe it or not, there are AIDS victims in Tucson. We need to develop an AIDS organization to help these people to be able to take care of themselves as much as possible. Currently there is no place for AIDS victims to go when they can no longer take care of themselves and/or become terminal. No local institution that offers care for the terminally ill will accept an AIDS patient when they get to this point. We must combat this problem plus, in the meantime, develop our own system to provide for these people.

This task will require a lot of work by a lot of people. We need your help after all, any of us could be the next AIDS victim.

Another problem is that there is no protection for Lesbians and Gays in employment outside the city limits. TLGPC has decided to propose a non-discrimination ordinance to the County Board of Supervisors. This will take much work and also people to testify in front of the County Supervisors to convince them why such protection is needed. Believe me, there will be people there to testify against us. We need your help.

I continually receive reports about "Queer Bashing". Some people are willing to report to the police while others are not. The police are doing their job. We need to do ours. We need to plan a self-defense and safety workshop. This takes time. Will you help?

It is also time to start planning for Pride Week '85. One week full of events will be scheduled. This is the biggest and most time-consuming yearly event for TLGPC. We need your help and ideas.

We must be willing to fight against those who oppress us. Unfortunately our legal rights do not come automatically. If you are willing

to join the struggle come to the next TLGPC meeting scheduled for next Monday February 11, at 8:30 p.m. at the Pineline.

By the way, in the proposed 1986 Federal Budget, President Reagan has decided to cut 10 percent from AIDS research. After all, Gay lives are not nearly as important as weapons.

### STUDENT SERVICES FOR LESBIANS/GAYS AND FRIENDS FILES SUIT AGAINST TEXAS TECH

LUBBOCK, TX - Student Services for Lesbians/Gays and Friends (SSL/GF) has filed action in federal court against Texas Tech University following Tech's denial of registration for the group as a student organization on campus.

SSL/GF president, Robert Reed Obenour, a senior architecture/civil engineering student, indicated the group's "disappointment at the administration's stand against allowing us the rights afforded other students at our university. We are extremely concerned that Texas Tech has chosen to address the issue by stating we would serve no educational purpose for the school, by bringing into the picture the desire to protect the student body from unspecified health dangers, and especially by attempting to reinforce its actions on a law that was declared unconstitutional over two years ago (Texas Penal Code dealing with sodomy).

"All persons, including Tech students, must deal with such a diversity of people, and that requires understanding and information. Our group is well qualified to provide that insight and education about the Lesbian and Gay community. We wish to dispel myths and misconceptions; we are not criminals. We are merely a minority because of our inherent sexual and affectional orientation."

The suit was filed through attorneys for Texas Human Rights Foundation at the request of Lambda Legal Defense and Education Fund, Inc. (LLDEF), which is involved in legal cases across the nation, countering discrimination against Gay men and Lesbians.

## Unique Dignity Conference

WEST HOLLYWOOD, CA - Less than a year ago 8 of the 10 Past Presidents of DIGNITY/Los Angeles, the founding chapter of the International Gay & Lesbian Catholic Lay ministry organization, met to form a Council to not only assess their terms of office but the organizations past and future. Their year's preparation resulted in a January 12th Conference in Plummer Park, West Hollywood with some fifty representatives of Dignity's chapters present.

The Conference, entitled "Creating a Vision for Dignity", featured Patrick X. "PAX" Nidorf, former Augustinian priest, of San Diego and Fr. Larry Tozzio, OFM, of San Francisco. PAX founded the International movement by "rap" meetings with a group of Gay and Lesbian Catholics in Los Angeles in 1968. When he was asked by the group to seek "official approval" the archdiocese declared him unwelcome and to desist further ministry. The lay group then founded the non-profit ministry

with more than 100 chapters in the United States and Canada, and has been the model for similar unaffiliated Catholic Gay organizations in dozens of countries around the world.

This was Mr. Nidorf's first Dignity presentation since the early 70s. He views Dignity as an enormous support function for Gay and Lesbian Catholics and a tremendous resource for the larger Gay communities. He cautioned not to expect fundamental change in hierarchical attitude but to individually respond to God's love to each human being, with or without "official support" or favored crumbs of tolerance. "Whether or not the church's love will change is rather insignificant. We know that God's love will never stop."

Dignity's next Convention takes place in New York City in August 1985. Locally, the organization's Tucson chapter meets regularly. Please call Dignity/Tucson, 745-1812 for further information.

## TUCSON COUNSELING GROUP FOR FEMALE PARTNERS OF GAY MEN BEGINS MARCH 4

TUCSON - Dr. S. Mae Smith will conduct an eight-week counseling group for straight women who are partners of bisexual and/or Gay men. Women participants may be married to the Gay partner, may be anticipating marriage or have been otherwise involved in a long-term and/or committed couple relationship. In addition, the group may also be helpful to women who believe that some marital/couple conflict may be attributed to their partner's sexual orientation. (The group will not help determine whether the male partner is Gay or not, but will help a woman who is unsure to recognize her own feelings, to determine how her own behavior is affected by those feelings and to discuss what she may be able to do to deal with her feelings in a manner that is least disruptive to the relationship.

Although the group experience will offer opportunities for support and education it is primarily designed for women who would benefit from an opportunity to explore personal feelings, attitudes and behaviors, and who are receptive to making personal changes.

The group will operate on the premise that each female partner's situation is highly individual and unique. Thus, the purpose of the group will be to aid each participant in exploring her own situation and feelings and to assist her in finding her own direction.

During the eight weeks, participants will have an opportunity to explore and examine personal values, beliefs, feelings and coping strategies. Participants will be asked to make a commitment to respect confidentiality of all information discussed within the group.

The number in the group will be limited to eight, each of whom will make a commitment to attend all eight group sessions. A screening interview is required. There is no fee for the interview but no one will be accepted into the group who has not completed the screening interview. ## TV SHOW SEEKS GAY PARENTS AND PARENTS OF GAYS

TUCSON - James Farías, producer of the nation's first regularly scheduled talk show about homosexual and Lesbian issues, "Arizona Gay", on Cox Cable Channel 37, is seeking Gay fathers and Lesbian mothers as well as parents and friends of Gays and Lesbians to take part in panel discussions on television.

In its first season of ten shows, "Arizona Gay" covered such issues as "Coming Out", "Gays and Religion", "Lesbians - Women Who Love Women", and "Gay Resources". The program also offered coverage of such events as the Tucson Lesbian and Gay Pride Committee's panel on Gays and Law Enforcement (with representatives from the Tucson Police Department and the Pima County Sheriff's Department) and the Mr. Tucson and Mr. Arizona Leatherman contests.

With the help of a grant from the Tucson Community Cable Corporation, Farías will produce at least 12 more shows this winter and spring including discussions of AIDS; Transvestites and Transsexuals; Job Discrimination Against Gays; Gay and Lesbian Parenthood; and Relationships of Gays and Lesbians with "Straight" Family and Friends.

The "weekly forum about being Gay in a straight society" also includes a Calendar of Events listing various groups and events that might be of interest to the Gay community. Response to the show has been very positive, according to Farías, and he has received many letters from national organizations expressing their support and encouragement.

The show is aired only on Cox Cable Channel 37 as part of local public access television administered by the Tucson Community Cable Corporation. It is seen Thursdays at 9:00 p.m.; Fridays at Noon; Saturdays at 4:00 p.m. and Sundays at 6:00 p.m. For the benefit of those who do not have Cox Cable, the show will also be shown on large screen television in the BFR at the Fineline/Tucson on Thursdays at 7:00 p.m.

**Learning From Our Past: NAZI GERMANY** by Mark Kasel

Hitler's "historic mission of destiny" began in 1919 at the end of World War I. Germany had been defeated and conquered. Everywhere there was gross poverty and rampant inflation, but above all there was what Germans call their "delirium of despair". For many young people the fever of the delirium broke and became a sexual revolution, which for homosexuals gave rise to the world's first organized Gay Liberation (for as it was called then, the Homosexual Emancipation Movement) and Women's Liberation movements. There were as many homosexual publications and bars as there are in New York City today. And there was talk about the feasibility of forming a national homosexual political party. Germany was widely seen as "the most homosexual nation on earth." A situation not dissimilar to our own situation today.

Germany's capital, Berlin, was the notorious fleshpot of Europe. "Pure sleaze" would not be an exaggeration in describing a city that "was the best of worlds and the worst of worlds, where cultural life was the most creative in Germany's history, where creativity in all fields of human endeavor was simply astounding," according to Frank Rector author of "The Nazi Extermination of Homosexuals."

But this beautiful mushrooming of the human spirit did little to advance either political freedom or democratic institutions. What it did was advance the political career of Adolf Hitler. In his attempt to control the present, Hitler utilized the dictums of the past. He made political hay denouncing the "pleasure-lust and sexual obsession" of the period. The fonts of moral turpitude were the Weimar Republic and the Jews. The Jews were deliberately engineering moral decay because, exclaimed Hitler, they were the enemy of volkish values and morals. Similar hysteria about homosexuals did not lag far behind. Of course, Hitler brought down all three of his "enemies of the State."

There were homosexuals working at advancing political freedom. One was Adolf Brand, an activist for penal reform, particularly reform of Paragraph 175, the law criminalizing

homosexuals and homosexual acts. Magnus Hirschfeld launched the first homosexual emancipation organization, the Scientific Humanitarian Committee. Hirschfeld was a Jew, transvestite and effeminate homosexual - everything Hitler ever hated in one person. The first Nazi book-burning consisted of holdings from Hirschfeld's Institute of Sexual Science and consequently, materials from the origins of Gay Liberation.

book burning led to much more overt and systematic homophobia.

Controlling the past had also been a failure for the general German populace and did not bode well for controlling the future. Said one historian: "Freedom, justice, tolerance and decency have never struck deep roots in the German political tradition. In that sense, Germany has not been a normal, civilized country, they had a true tolerance for sexual diversity or not, they were accommodating to the prevalent homophobia of the time, because the real world, particularly when times are bad, has a way of imposing its own realities upon those who have no vested interest in living in a world of delusion.

Along came Hitler who knew that, a conversely, dark times can also brew a vested interest in delusion. He exploited the irrational side of human nature, both in himself and others, with shrewd calculation; then his followers themselves completed the conversion.

One such follower was a powerful, violent, corrupt and flamboyant homosexual named Ernst Rohm. He became Chief of Staff of the SA, Hitler's Storm Troopers. The SA was largely responsible for carrying Hitler to power. Rohm wanted to press on with a Second Revolution throughout Germany; Hitler was intent on rearmament and subjugation. That was Rohm's conversion and his downfall. Once Hitler had secured total power for himself he ordered the execution of Rohm and all of his homosexual leadership. In a Blood Purge aka Operation Hummingbird aka Night of the Long Knives, Hitler's exploitation of homosexuality as a pretext for the Purge led him to abandon all pretense of justice after June 30. On June 30, the SS was the winner and Dachau its everlasting monument.

Do not look to Dachau for any memorials to the homosexual genocide that followed the Purge. There are none. We know that at least half a million homosexual lives were sacrificed in the guise of a macabre contribution to Fascist statecraft. Their lives were sacrificed to a system they were willing to build, but one in which they were not suitable to live. Many of the homosexual Storm Troopers had the same qualities as the homosexuals who resisted police harassment at the Stonewall Inn. They were flaming faggots, they were fighters, they were proud and they would not tolerate any interference

## A View From Within

### CONSENTING ADULT: A LANDMARK AMONG LANDMARKS

On February 4, the American Broadcasting Company (ABC) televised the movie **CONSENTING ADULT**, which dealt with a husband's and wife's reaction to the discovery that their only son was Gay.

The subject of homosexuality is not new for film or television. Landmark television films include **THAT CERTAIN SUMMER** about a son (Emmy winner Scott Jacoby) who discovers that his father (Hal Holbrook) is Gay. This 1972 film directed by Lamont Johnson was a sensitive treatment of a then controversial subject. **THE MAKING OF A MALE MODEL** with the now deceased Jon-Erik Hexum had several peripheral Gay characters, and a particularly good passage of dialogue by co-star Joan Collins about how inconsequential being Gay was in the whole scheme of things, as long as you did your job well.

There was Billy Crystal's detrimental portrayal of a Gay on **SOAP**, a role which did much to put the homosexual back in the closet. There is cable television's **BROTHERS** on Showtime, and the theatrical films **SILKWOOD**, **MAKING LOVE**, **CRUISING**, **VICTOR/VICTORIA**, **PROTOCOL**, and others.

Even the pilot for ABC's **PAPER DOLLS** had a Gay make-up man and his lover (who were both conspicuous by their absence on the short-lived television series).

Most notable now, is **DYNASTY**'s Steven Carrington finding his true feelings for his employee Luke Fuller on the January 23rd episode. (See also **A VIEW FROM WITHIN** 12 December 1984 "Gay Life As Portrayed On **DYNASTY**").

So, was **CONSENTING ADULT** just one more Gay film? Yes and no.

**CONSENTING ADULT**, based on the novel by Laura Z. Hobson (who also wrote the anti-Semitic story of **GENTLEMAN'S AGREEMENT**), introduced to the movie voyeur what can happen when a typical family is suddenly thrust into a situation unplanned and unprepared for.

The cast of Marlo Thomas as Tess, Martin Sheen as her husband Ken, and Barry Tubb as their son Jeff, was top-notch. Ms. Thomas gave what could easily be the performance of her career as the bright, restrained mother who

does what she feels she must for her son. Barry Tubb, as the son, represented someone with whom we all can identify. And his performance (especially the "consenting adult" scene when he announces that he has stopped seeing his psychiatrist) would easily qualify as award quality. Upon seeing his performance in a sneak preview, I was silently cheering him on, tears in my eyes. He did what all of us may have wished we could: Stand up for our right to be ourselves.

My "coming out" was much more restrained, but since then I have crusaded for Gay civil rights and felt the energy and passion I saw in Jeff's eyes in that scene. Powerful.

What effect will this have on the world outside of the Gay community. Idealistically, everyone will say to hell with class distinctions and all discrimination will end abruptly. Realistically, many parents will re-examine their feelings, and many children will receive enough encouragement from this film to be honest with their parents and with those significant others in their lives who love them. No one knows exactly what effect this film will have, although a \$1 spot on the Neillsons would be a nice place to begin. We all can, however, be directly responsible for one effect: Let the networks know you appreciate this film.

with their sexual identity and their sexual preferences. They won on their terms and the durability of their prize has become stuck with the name of Gay Liberation. Liberation was not then and cannot become now "Teflon-coated,"

that is, nothing that we accomplish as a community sticks to us. We must know what we want and own what we will fight for. That will be our contribution to our statecraft. Teflon-coated Gay history belongs to the gas chambers and to those we mourn who had "nowhere else to go."
