

—New Mexico Governor Signs Anti Discrimination Executive Order—

SANTA FE, NM — New Mexico Governor Toney Anaya signed a far reaching Executive Order on April 1 prohibiting discrimination on the basis of "sexual preference" by the executive branch of state government and by those who contract with the state.

The Order bans discrimination by any state agency or department on the "basis of sexual preference" in state employment, in providing state services and benefits, and in awarding state contracts. The Order also provides that "all such contracts shall include a provision that the contractor shall not discriminate on the basis of sexual preference in any matter relating to employment."

Governor Anaya, a Democrat, signed the Order without announcement or publicity. "We didn't find out about the Order until April 4th, and we didn't get a copy of the Order until the 6th," said Adrienne Edwards, vice president of the New Mexico Lesbian and Gay Political Alliance (NML/GPA).

Although, the Order was issued at the request of NML/GPA, it was the efforts of members of the Governor's administration who gained the support of Anaya for the Order. In October Anaya asked his staff to prepare the Order, but he waited until after the general elections and the legislative session to sign it.

The full impact of the order has not yet been fully determined by Lesbian and Gay leaders. The order clearly does not cover employees of other state elected officials, but the contract provisions of the Order extend its effect far beyond agencies and departments directly within the control of the Governor's office.

Efforts to gain an Executive Order began when NML/GPA member Don Schmidt met Ron McDaniel, an openly Gay member of the governor's administration. Schmidt asked McDaniel if he would approach the governor about an Executive Order banning discrimination on the basis of sexual orientation. McDaniel agreed if NML/GPA would submit a formal request.

Initially McDaniel approached Governor Anaya's top aides, Harvey Fruman, Bob McNeal and John Ramming. "The response among the governor's top three aides was unanimously supportive," said McDaniel. All three of them and the Governor understood that it was the right thing to do.

After discussing the matter with the governor's aides, McDaniel obtained a formal letter of request for the Order from NML/GPA along with a complete packet of information about executive orders in the five states that already had them. McDaniel also wrote a personal cover letter

recommending that the Governor issue the Order.

Secretary of Human Services Juan Vigil was approached, and he too wrote a personal letter of support. According to McDaniel, Vigil's letter was particularly persuasive in that it appealed to the Governor's special concern for the issue of civil rights. Vigil also advised the Governor that his department had already adopted a non-discrimination policy with respect to sexual orientation and that the policy had been specifically written into the Department of Human Services' union contract with its employees.

Within a few days of receiving the request, Governor Anaya asked his aides to prepare him an order for consideration. After some confusion as to who was to prepare the order, Dick Ruben, legal counsel for the Department of Human Services, prepared a proposed draft and submitted it to the Governor.

The Governor did not act on the Order at that time presumably because of its possible impact on the upcoming elections. After the elections McDaniel, Vigil, Ruben and Denise Fort, the Secretary of the Department of Environment, pressed the Governor at every reasonable opportunity to act on the Order.

In March, State Representative

Cleto McSorley urged the Governor to sign the Order, and the Governor promised to do so as soon as the legislative session was over. After the Legislature adjourned in mid-March, the proposed Order was again reviewed by Anaya's staff, a few minor changes made, and on April 1, the Governor signed it.

"We are very grateful to Governor Anaya," said NML/GPA President Russel Gray. "The Governor's Order if properly enforced should provide protection for thousands of this state's Lesbian and Gay employees and the contract provisions extended that protection to almost every person who works for a large employer in the state."

"We are also very grateful to Ron McDaniel, Secretary Juan Vigil, Secretary Denise Fort, Dick Ruben, and those within the Governor's staff who have worked so hard to see that this important issue is addressed," Gray added.

NML/GPA has asked that everyone, particularly those who are members of the Lesbian and Gay community write the Governor and thank him for issuing the Order. Current National Update On AIDS

Last Monday, April 15, there began a national conference on acquired Immune Deficiency Syndrome (AIDS) at the Centers for Disease Control in Atlanta. Between 2,000 and 3,000 scientists are in attendance. On Monday, NBC-TV's "Today Show" held a live interview with Doctor James Curran, AIDS Task Force Director for the Centers for Disease Control. Here, then, is probably the most up-to-date information concerning AIDS on the national scene:

NBC: Doctor, you were just telling me that there are almost 10,000 cases of AIDS in the United States, is that true?

JC: Yes, there are 9,508 as of this morning, with over 49% or 4,700 people who are reported to have died.

NBC: And just to repeat what we have said often in covering AIDS, there's no cure for this disease is there? It's a fatal illness?

JC: There essentially is no cure for the virus that causes AIDS, HTLV-III-LAV.

NBC: Now, the discovery of the virus has not led to any diminution of the number of cases. There still is an enormous increase of cases, correct?

JC: Well, as a matter of fact, it has allowed us to estimate that there are several hundred thousand people infected with the virus. It's led to much greater understanding about the disease, but it also has led to greater awareness of the severity of the problem.

NBC: This is the biggest conference on AIDS that's ever been held with between two and three thousand scientists gathered here in Atlanta. One of the themes that we're hearing a lot from everybody is that AIDS has been limited to mostly male homosexuals and intravenous drug users. But there is an expectation that it is going to start spreading among heterosexuals. What can you tell us about that?

JC: I think that the papers presented from over thirty countries at this conference will point out that sexual transmission, per se, is the major mode of transmission. In the United States it's been homosexual transmission. In many other countries it has been heterosexual transmission. I think in the United States we will see an inevitable increase in heterosexual transmission, but probably at a much

slower rate than we have among homosexual men.

NBC: When you say a slower rate, you say hundreds of thousands of people probably have already been infected with the disease. We know it can be years, sometimes, between the time of infection until somebody gets the disease. How many people in the United States do you think are going to get this disease before this is all over?

JC: Well, it's merely a guess how many people are currently infected. My guess would be somewhere between 500,000 and one million in the United States.

NBC: A million people will be infected with AIDS virus?

JC: A million have been...

NBC: Have been already infected!

JC: It's likely that between five and ten percent eventually, of that group, will develop AIDS. If transmission can be interrupted or slowed down, then that would be very good.

NBC: You're talking about the spread among heterosexual being maybe slower than it is among the homosexual community, but does this mean that young people, or anybody who is sexually active should start worrying about AIDS now, they way they worry about gonorrhea, herpes or other venereal diseases?

JC: Well, the presence of the virus in semen and the presence of the virus in white blood cells would indicate that it can be heterosexually transmitted. The prevalence of infection among heterosexual men and women, is much lower than it is in homosexual men. So, the risk from a single sexual contact remains much lower. But, indeed, in the future, heterosexual transmission will be increasingly important.

NBC: Sounds like a very frightening prospect, both for the homosexual community and almost everyone who would be sexually active, who perhaps isn't married and in a stable relationship.

JC: I think that it is a serious problem and it will take a long-range commitment from all of us to solve it.

NBC: What is the outlook. Right now we have a big conference. All the people are talking. We've discovered the virus. There is no cure though, and it doesn't look like there is any prevention in the near future.

JC: Well, I think that we've learned much more about this virus. The amount of scientific intensity; the amount of work that's been done in the last four years, has been very impressive. The commitment on the part of the scientific community, the public health community, the media has been very helpful in terms of focusing on the problem. We've gone a long way toward protecting the blood supply, and protecting future hemophiliacs from disease. If we can make the same kind of progress in the other areas with vaccine, therapy and prevention techniques, then, perhaps, there is a promising outlook for the future.

NBC: Okay, but with a million people infected it's not that promising. Dr. Curran, thank you very much for being with us this morning.

Teenager plea bargains in Benson murder

BENSON, AZ — A seventeen-year-old runaway from Michigan has entered a guilty plea to a reduced charge of second degree murder in connection with the killing of a 34-year-old Gay nurse. Authorities in Cochise County agreed to drop the charges of first degree murder, kidnapping, aggravated assault and grand theft in exchange for the second degree murder conviction. The youth, Troy Fulmer, and a fourteen-year-old companion are accused of beating and stabbing Charles Bush to death last October 29.

Benson police believe that on the night of October 29, 1984, Bush had been driving his van from Tucson to his mobile home in St. David when he apparently picked up the two teenagers near Tucson. On the basis of confessions made by the teenagers, authorities believe that Bush brought them to his home where a scuffle ensued. Bush was struck in the back of his head, a blow that pathologist Guerry Flores said should have knocked him out or at least incapacitated him. The youths then got Bush back into his van, and Fulmer apparently drove, leaving Bush and the younger boy in the rear of the van. Then, another scuffle occurred, this time between Bush and the fourteen-year-old. At that point, Fulmer allegedly stopped the van and went back to complete the killing. The autopsy showed that Bush bled to death from a severed femoral artery, one of three stab wounds he suffered before dying. In addition, the autopsy showed a fractured skull and broken nose. Bush's body was found the following day, adjacent to a rest area in Benson. The teenagers were subsequently arrested in Texas. (Observer Nov. 21 and Dec. 27, 1984).

Although police concede that homosexual advances may have prompted the crime, Bush's lover of ten years, Roy Patterson, asserts that this theory is very unlikely. In an interview with Benson radio station KAVV (97.7 FM), Patterson pointed out that on the night of the murder he had been a patient in a Tucson hospital and Bush had come to Tucson to visit him. According to Patterson, Bush never picked up hitch-

TUCSON - The Student Repertory Company, an independent performance group composed of University of Arizona students, has announced its next production - Three, one-act, plays exploring the absurdities and paradoxes of life in modern America. The plays will be presented Saturday and Sunday, April 20 and 21 and again on April 27 and 28 at 3:00 p.m. and 7:00 p.m. in "The Cellar" in the U. of A. Student Union Building.

Two of the plays are by the outstanding American playwright/actor, Sam Shepard who most recently wrote the screenplay for the award-winning film "Paris, Texas" and starred in "Country". The one-act plays are characteristic of his unique style (sometime labeled bizarre realism) which incorporates sharply drawn characters and elements of American myth with an ominous surrealist edge.

"Icarus's Mother", is a parable of the post-nuclear age and won an Obie award as best Off-Broadway production in 1966 (one of ten Shepard has won, five times more than any other playwright). Meg Nolan will direct the Tucson production.

Gretchen Gates will direct the second play, "Fourteen Hundred Thousand". It is a dramatic analysis of the contradictory nature of human intellect and industry.

GOSPEL CONCERT BY "SONLITE" SCHEDULED IN PHOENIX

PHOENIX - "Sonlite", the popular contemporary Christian music group from Southern California, will be hosted in its first Arizona concert by the Oasis Metropolitan Community Church on Saturday, May 4. The concert will begin at 8:00 p.m. in the Danforth Chapel on the campus of Arizona State University, Tempe.

"Sonlite" began as a group of three performers based at the Long Beach, California MCC three years ago. It has grown to a chorus of eight singers and two sound technicians from several MCC's in Southern California, and they have carried their ministry of music to appreciative ears all over the Western United States. "Whether it is a church basement, or a neighborhood bar, 'Sonlite' will share Jesus Christ's glory and gospel eagerly with all."

Combining the best in contemporary Christian music with the traditional songs found in all church hymnals, "Sonlite" moves hearts for Jesus Christ in a fresh new way. ONLY 37% OF S.F. GAY MEN EXPOSED TO HTLV-III

SAN FRANCISCO, CA (OCN) - A new study shows far fewer Gay men have been exposed to HTLV-III than previously believed, according to the Bay Area Reporter. The \$3 million federal study indicates that the local exposure rate is 37 percent, while earlier studies calculated exposure at 65 percent.

Earlier studies, however, have been criticized for recruiting subjects among groups who had contracted venereal disease or hepatitis. The new study, which is still underway, uses "population-based, random sample" survey techniques.

Because San Francisco has the highest incidence per capita of AIDS, the fact that more than half of Gay men here have not yet been exposed is encouraging.

Researchers hope their findings "will inspire additional public education efforts...and encourage homosexual men to...undertake other measures to limit their possible exposure to the AIDS virus."

TUCSON - On Friday April 12 during Women's Week at the University of Arizona, representatives of the Tucson Lesbian and Gay Pride Committee presented a workshop on the unification of Lesbians and Gays in the struggle for equal rights. I am proud to say that I became the first Gay man ever to present a workshop at Women's Week. Many at the workshop said of all the other ones they had attended, this was the most educational and interesting.

As some may remember approximately three years ago there was a large split between Lesbians and Gays in Tucson. This division happened as a result of planning for Pride Week 1982. There was much argument between the men and women over including the word Lesbian in the title for Pride Week. We have come a long way since then and I am happy to say that out of nine officers of the Tucson Lesbian and Gay Pride Committee, four are women. TALHA urges against HTLV-III test

TUCSON - The HTLV-III virus discovered in 1984, is believed to be the causative factor, or at least a greatly contributing factor, in the development of AIDS (acquired immune deficiency syndrome). A blood test, which identifies antibodies to the HTLV-III virus has recently been licensed by the Food and Drug Administration. (Observer March 6). Antibodies are substances produced by the body's white blood cells in an effort to fight infection. Thus, people with HTLV-III antibodies may have been infected with the HTLV-III virus.

The test was developed to screen blood donated at blood banks, since AIDS has been transmitted with transfused blood. The blood test is NOT a test for AIDS. A positive test result does NOT mean that a person will develop AIDS. Based on current information, most antibody positive individuals are well and will not become ill. Why the HTLV-III virus has such varying effects in different people is not known. The test also has a high number of falsely positive results.

Because of the uncertainty of what a positive test means, we are currently advising against using this test as a routine screening device. The test will not be offered as a service of the Tucson Alternative Lifestyle Health Association (TALHA) Clinic. The possibility of job, housing, insurance, or other social discrimination directed against HTLV-III positive people is unfortunately real. In addition, some individuals may not be able to handle the pressure of the uncertainty of their HTLV-III positivity - wondering if they will be the next to develop AIDS. (Observer Jan. 23 and March 20).

The Tucson Alternative Lifestyle Health Association strongly urges those at greatest risk of developing AIDS to continue lifestyle adjustments which may minimize the risk of acquiring AIDS. These measures include limiting the number of sexual partners, limiting the exchange of body fluids, and avoiding IV drugs. TALHA also strongly encourages continued avoidance of blood, plasma, body organ or sperm donations.

NEW RULING IN LIBERACE PALIMONY CASE

LOS ANGELES, CA - A Superior Court judge recently refused to dismiss Liberace as a defendant in the suit brought by Scott Thorson over a 1982 Globe International article titled "The Wicked Past of the Gay Suing Liberace."

The court also concluded that Thorson, who is suing Liberace for palimony support, is a public figure and must prove malice in his \$12 million libel suit against the entertainer and the tabloid.

Thorson alleged that he was previously Liberace's homosexual lover. He contends in his suit against Liberace, Globe and Thorson's half-brother, Wayne Johnson, that Liberace requested and paid for the article. The court ruled that the issue concerning Liberace's connection with the Globe story could go to trial.

Liberace's attorney said he was pleased with the judge's decision on the public figure issue, which will make it much more difficult for Thorson to prove he was libeled.

UNMARRIED HETS GET OKAY ON SEX

RICHMOND, VA (GCM) - Virginia laws prohibiting unmarried, consenting heterosexual men and women from living together and having sex were declared unconstitutional late last month by a Federal judge, according to the Washington Post.

District Judge Robert Merhige Jr. said the laws on heterosexual acts were in violation of an individual's right to privacy, were too broad, and should not be enforced. Records indicate at least eight arrests on "fornication" charges in Richmond since 1982.

The unmarried couple who challenged the laws said in affidavits that the fear of prosecution had led them to abstain from sex and intruded on the right to "happiness as a single person."

The decision does not directly affect law prohibiting homosexual acts or prostitution, according to Bert Newborne, national legal director of the American Civil Liberties Union, but the ruling "sets up an argument" against use of Virginia's sodomy statute against homosexuals.

T-ROOM BUST, MAN COMMITS SUICIDE

ST. CATHARINES, ONTARIO, CANADA (GCM) - Thirty-two men were charged with 49 sex-related offenses after a police investigation into allegations of "unusual behavior" in the Fairview Mall here, according to the St. Catharines "Standard". And one of the men charged has committed suicide. The investigation was prompted by complaints from mall shoppers that the men's washroom was serving as a place for homosexual encounters.

During the course of a week, the Niagara Regional Police hid video cameras over the ceiling of the washroom and recorded various sexual acts from masturbation to fellatio and "attempts at self-humiliation".

In January, the thirty-two suspects were telephoned by police and asked to come to the station where they were served with a summons and given a date to appear in provincial court. The police also released the names and addresses of the men charged, which were then published in local newspapers.

Toronto members of the Metropolitan Community Church have protested the investigation and the publication of suspects' names and have picketed the regional headquarters of the Niagara Regional Police.

So far three men have appeared in court and pleaded guilty, receiving conditional discharges (the condition being that they not go back to the mall washroom) and probation for periods up to three years.

One accused man, Clarence Warren, has committed suicide. According to the Niagara Falls Review, after Warren returned from the police station where he had received the summons, he kissed his wife and children goodbye, drove to a nearby village and set himself on fire with gasoline while driving slowly down the street.

EXCERPT FROM MY PERSONAL JOURNAL: 07 APRIL 1985

HAPPY EASTER!

I sure got a surprise this morning: Marissa called from San Francisco. (I tried calling her yesterday and, per for the course, she was not at home.) Her call woke me, but it is the way I wish I could be awakened everyday. Apparently, Ricky is finally due home on leave. This is the last time he will be here for over a year. Don't they let them have more time off than that from the Coast Guard officer's training? Seems unfair...The big party for Ricky is supposed to be next Saturday 13 April. I must go, but I might not be able to rearrange my schedule to get there. This will be my last chance to see him for some time.

Called Kathleen, last night, before I went to HOTEBOOS. Am so happy she was home. Apparently Mark is down with a flu-bug or something. Poor baby...It is probably just the weather in Salinas getting him down. Told Kathleen of the dream I had of her last week, about seeing her -- all dressed in white -- running up to her, hugging her, crying, and telling her how much I missed her. I remember awakening feeling very lonely and depressed. She is still discontented about working at Saks. She is trying to get a job working at Express. I told her that one opened here at MetroCenter. Maybe she could transfer.

Tried calling Olga last evening. She wasn't home. She was in Monterey still for a wedding -- which is why Marissa wasn't home last night either. I miss her, too. She is so fun. Marissa told me about how Olga wants to hear the tape I sent to Kathleen, but, because of the part about _____ she can't. I told Marissa to erase that part so that Olga could hear me spashing in the tub...

Called (twice!) and finally got a hold of Michael R. He and his boyfriend Jeff had been out getting tickets for the big Easter fest at the Trocadero. I still cannot understand how he can tolerate those events. He said he was going to wear all white. How appropriate. A big, muscular, handsome Puerto Rican -- with a deep, dark, (artificial) tan -- in all white: My heart just stops when I think about him. He could be a great modelling talent if he would just put his mind to it. So handsome! I am sure glad that we met at B Street last year, and are great friends now. He did, however, get quite unnerved about the April Fool's letter I sent him last week. I began the letter telling him how I was going to get married -- to a real woman! I told him I wanted to put my sordid (Gay) past behind me, and begin to live life straight. I even invited him to be my best man, and suggested

that he not bring Jeff. "I mean," the letter said, "how would that look, two men together?" I told him that he was the only person on whom I could have played that joke. I'm sure glad that it worked. He and Jeff are trying to find a place in the East Bay: Orinda or Concord. He is tired of the fog in Daly City. I love it. I lived in the East Bay (Pinole) for a couple of years, and just hated it. (weather-wise). I keep telling him to move to Phoenix.

Also called Lisa. I never knew this, in the 12 years that I have known her, but she is actually petrified of tornados! Living near Dallas, though, I can see why... She seems to forget about the BIG earthquake I survived last April. Boy, the ground shook and shook. It didn't help that I live on the landfill under Foster City, and that we are so close to the epicenter of San Jose. Lisa says that her kittens are fine -- including the 14 pound one. She tells me that when there is a tornado alert, she packs them into their cat carriers, puts them into the tub, and covers them with a mattress. What a sight THAT must be. She has been working for hours and hours on costumes for the next Renaissance Faire. Boy, she loves those. No word on when she is moving back to Tucson. I guess there are still no openings at Kitt Peak.

...and so it goes. I'm sunning next to the pool on Easter afternoon. Alone. (And, after that fiasco last night, I have really given up on men -- for the umpteenth time, it seems. This time, forever. I'm sick of being so loving and caring, and being the only half of a relationship that seems to care. I'm tired of being kicked in the face every time I turn around. Why can't someone love me?)

But then again, it doesn't really matter. Dad and I were talking about happiness the other day. He seems to think that flashy cars, houses, furnishings, and material things make someone happy so they should have them. I'm glad that I know better. I know that after all of the material things are gone, after the money has all been spent, that I will always have Lisa, Kathleen, Marissa, Olga and Michael. The six Muskateers! No matter how many land miles may ever separate us, no matter how many days we may be apart, they will always be right next to me -- shoulder to shoulder -- in spirit. I love them so very much. This feeling of love for them, and their love for me makes all the bad things in my life seem unimportant. It makes me feel very content. This, for me, is what happiness is all about.

GAY MAN'S SUIT IN SECRECY CASE DISMISSED

SAN FRANCISCO, CA - A Federal Appeals Court has dismissed a lawsuit filed by a homosexual who sued the government to find out why he was refused a special security clearance.

The three-judge panel ruled that the government had a right not to provide Richard Gayer, an electronic engineer who works for GTE Government Systems of Mountain View, with an explanation because to do so would reveal classified information.

Gayer, who argued his own case, said he believed that the CIA vetoed his security clearance because he is a homosexual. He claimed that GTE withdrew his application for clearance at the request of the government after the CIA learned that he is Gay.

Gayer's suit asked the government to explain why his industrial security clearance application was denied and asked for an injunction to end all alleged policy of refusing security clearance to homosexuals.

The judges agreed with the Justice Department that the government could not explain its denial without possibly disclosing classified information. In their decisions, they held that the privilege of the government to withhold the information from Gayer had been validly invoked.

AMERICAN LEGION ADMITS GAY CHAPTER

SAN FRANCISCO, CA - Facing a lawsuit and possible anti-discrimination investigation, the San Francisco chapter of the American Legion has decided to accept a Gay veterans' chapter in its ranks. The Legion had turned down the Alexander Hamilton Veterans Association (AHVA) last year, but the local chapter filed a complaint with the San Francisco Human Rights Commission, charging anti-Gay bias.

"We intend to file suit against the individuals who took this discriminatory action, as well as your organization," AHVA lawyers said. As a result of the change in heart, AHVA now will be able to use the city's Veterans Building for fundraisers and rent-free office space.

IF GEORGETOWN PLAYS FAIR

WASHINGTON, DC (CCN) - Mayor Marion Barry has resubmitted legislation to the Washington City Council to issue \$70 million in bonds to renovate Georgetown University, provided the school does not discriminate against Gay students, according to the Washington Post. Barry's proposal, which does not guarantee official recognition of Gay/Lesbian student groups, has been called an acceptable compromise by activists here.

The university is currently engaged in a court battle with Gay activists over its refusal to give campus privileges to Gay/Lesbian student groups.

The case comes from a suit filed in 1980 against the university by two Gay/Lesbian student groups. A District of Columbia Superior Court Judge ruled in 1983 that Georgetown may deny privileges to Lesbian/Gay groups because the university's Catholic beliefs against homosexuality are protected by the First Amendment.

PARENTS PROTEST EDUCATION

CHICAGO, IL (CCN) - Prompted by letters from Phyllis Schlafly, parents in 25 states are demanding that teachers obtain their written permission before teaching "sensitive" topics, according to the Chicago Sun-Times. The 34 topics include death, abortion, nuclear war, homosexuality, witchcraft, anti-nationalistic politics and communism.

At least one school system has responded by warning new teachers to handle such issues with great caution. Teachers' union officials fear the campaign could pressure textbook publishers to pre-censor textbooks.

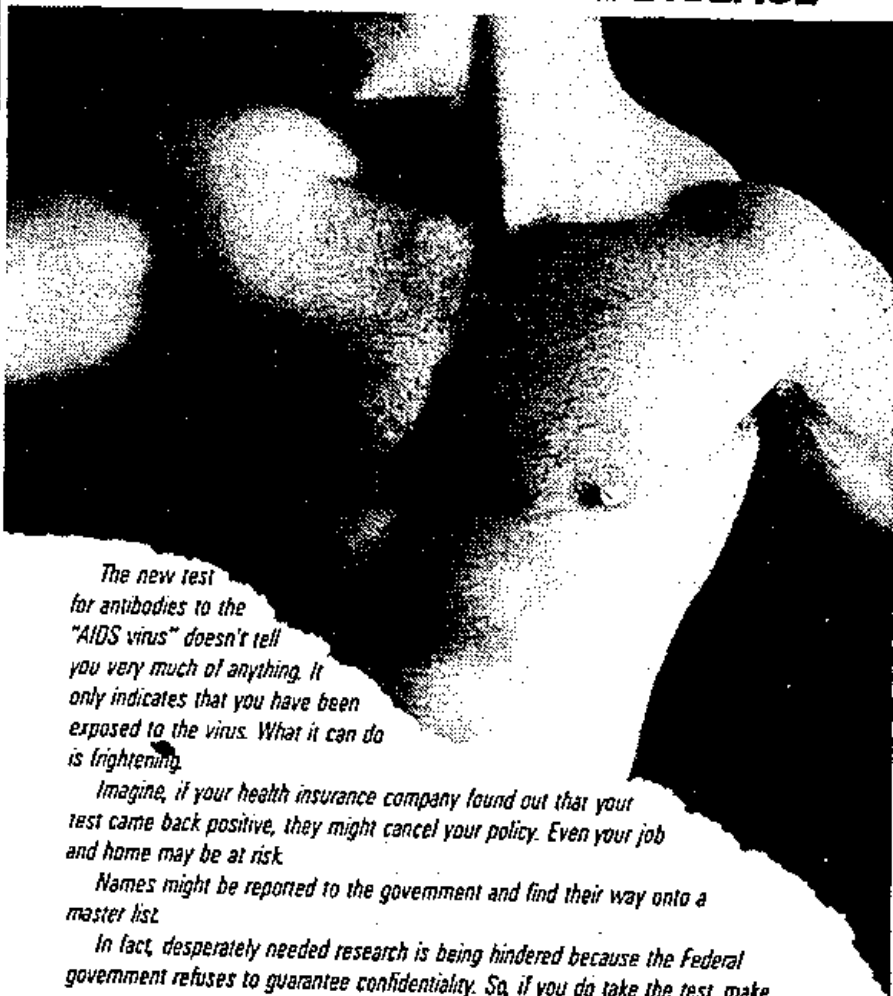

Fulmer is scheduled to be formally sentenced on April 29. According to Cochise County Public Defender Wall Hoggatt, Fulmer is to receive a ten-year sentence but he could be paroled after five years. Meanwhile, the younger boy awaits trial in juvenile court. If convicted, he could be held in custody until his eighteenth birthday.
