## Military can't release names of recruits with signs of AIDS

WASHINGTON, DC - The Pentagon's top doctor has ordered the armed forces not to release the names of individuals rejected for military service after showing signs of exposure to the virus that causes AIDS, unless the civilian health authorities formally request the information.

Dr. William E. Mayer, assistant secretary of defense for health affairs, took the action saying there had been news reports that some military officials had been trying to give local health departments the names of the rejected recruits so the civilian health authorities could offer them counseling about AIDS, or acquired immune deficiency syndrome.

The New York City Health Commissioner, Dr. David Spencer, said he had rejected such an offer on the ground that it would constitute an unjustified invasion of the privacy of the individuals. An Army spokesman and other Pentagon officials said they did not know if similar offers had been made to other local jurisdictions, nor could they determine if any names had been turned over.

The offer was sharply attacked by leaders of groups concerned with civil liberties or homosexual rights. They expressed fear that the names inevitably would be widely circulated and used to deprive the named individuals of employment, insurance coverage and housing in a climate of "hysteria" over AIDS, which so far has mainly struck homosexuals.

The issue marks a new phase in an evolving controversy over how the military services should handle the results of screening tests used to detect exposure to the virus which has caused AIDS in some people but not in others.

The services recently began testing blood of all recruits for signs of antibodies to the virus. Such antibodies are an indication that an individual has been infected with the virus but not necessarily that he will come down with the disease, a fatal ailment that destroys the body's immune system.

Those who show signs of infection with the virus on two separate blood tests are told of the results and are rejected for military service.

In a memorandum sent last Friday, Oct. 11, to the secretaries of the Army, Navy and Air Force, Mayer said it was contrary to Defense Department policy to report positive results on the antibody test to civilian authorities "except in response to a valid civilian health authority request." Even in such case, Mayer said, only he, not the individual service, can determine whether the test results should be provided after receiving "a formal request" from the civilian authority.

Mayer drew a sharp distinction between reporting cases of the disease, AIDS, which is required by public health laws in most states, and reporting results of the antibody test, which is not required "in virtually all jurisdictions" and is explicitly prohibited in some jurisdictions.

The military's offer to identify the recruits rejected because of the antibody tests came to light when Spencer, the New York City health official, testified in court that an unidentified military doctor called him the week before and wanted to provide the names of people who tested positive for infection with the AIDS virus. It was unclear whether the names had already been compiled. Spencer said he refused to accept the names because he considered it a betrayal of the individuals' privacy.

Many health officials believe that if the identities of individuals infected with the virus are distributed too widely, people will be unwilling to take the screening tests and doctors may shy away from reporting the results. "The sharing of names could lead to the establishment of a whole class of untouchables," warned Thomas B. Stoddard, legislative director of the New York Civil Liberties Union. "It justifies our fears that this test will ultimately be used for purposes other than protecting the blood supply or seeking to stop the spread of the disease."

Stoddard stressed that a test result indicating an individual had developed antibodies to the virus had "no clear medical significance" because nobody knows for certain if these individuals will come down with the disease or will spread the virus.

## Man with ARC wins disability case

SAN FRANCISCO, CA (BAR) - In a decision that may help set a precedent, the San Francisco Social Security office has awarded benefits to a man suffering from ARC (AIDS related condition). It required the services of an attorney and a personal appearance before a judge, but 11 months after filing his claim the man received his disability award.

John Riordan, the attorney for the man suffering from ARC, said 25 percent of his practice is made up of people who are seeking Social Security and disability benefits. But Riordan said he had not previously represented anyone suffering from ARC. Also, according to Riordan, Judge Blume, who presided at the hearing, told him there were no agency regulations to guide him in making his decision regarding the disabled man. Social Security Administrative Law Judge Herbert L. Blume would only say that the disabled man had met the specific requirements for a disability award.

Those requirements are defined in Social Security regulations as, "A medically determinable mental or physical impairment which is likely to result in death, or has lasted or can be expected to last for a continuing period of not less than 12 months."

According to the physician's report that was submitted to the judge by Dr. Jeffrey L. Anderson, the man's problems began four years ago, though he had suffered from "malaise and severe fatigue" beginning 3-4 years before that. About 4 years ago, the report by Dr. Anderson stated, "he began experiencing recurrent lymphadenopathy of the neck and axillary areas, intermittent flu-like viral syndrome including marked myalgia, chills, sweats and frequent periods of diarrhea alternating with periods of constipation. He also began experiencing chronic recurrent nausea, dyspepsia, rectal fissures, most of the gastrointestinal symptoms being particularly acute two or three hours after eating."

"In the past two years," the doctor's report continued, "he has begun experiencing more frequent periods of light-headed dizziness, and more significant cognitive and cycloemotional cerebral dysfunction including loss of short term memory and recall, diminished ability to comprehend, particularly the written word, difficulty in concentration and focusing with attenuated attention span and more distractibility and neurologically increased dys-equilibrium....daily retrobulbar frontal headaches."

## FALWELL ORDERED TO PAY UP



Jerry Falwell on the ERA: "God did not make women for NFL football or combat."

SACRAMENTO, CA (BAR) - A Sacramento municipal judge has ordered Rev Jerry Falwell to pay \$5,000 to a Gay leader. However, the anti-Gay evangelist plans to fight the decision which awarded the money to Sacramento Jerry Sloan.

Municipal Judge Michael Ullman ordered Falwell to pay the money to Sloan after the latter claimed Falwell viciously attacked the Metropolitan Community Church during one of his "Old Time Gospel Hour" telecasts. According to Sloan, Falwell once referred to the MCC as a "brute beast"...."a vile and Satanic system" [which would] "one day be utterly destroyed and there would be a celebration in heaven."

Sloan confronted Falwell when the two appeared July 13, 1984 on a Sacramento television talk show on KCRA-TV. Falwell denied making the statements and told Sloan he would pay him \$5,000 if he could produce a tape. Sloan almost immediately produced a tape of the show. When his attorney, Rosemary Metrailler, wrote to Falwell and requested the money, the evangelist refused. After that, Sloan and his attorney decided to go to court.

When Falwell stopped in Sacramento during a fundraising tour on Sept. 30, 1984, Sloan presented Falwell with a subpoena. Almost one year later, Ullman rendered his decision in favor of Sloan. "The defendant [Falwell] offered \$5,000 to the plaintiff [Sloan] if he could produce a tape," Ullman said. "The plaintiff tendered the tape almost immediately, binding the plaintiff to his unilateral contract."

Falwell was unavailable for comment, but a spokesperson in the minister's public relations department in Lynchburg, Virginia, issued a statement which indicated this case was far from over. "This situation is only one more example of harassment by a militant homosexual group in Sacramento," said Diane Whitehurst, speaking for Falwell. "I believe homosexuality is moral perversion and have preached that for years."

"My condemnation of homosexuality on an Old Time Gospel Hour TV program was twisted in its interpretation by a leader of a homosexual church in Sacramento," Whitehurst went on for Falwell. "They even edited one of my tapes to distort it out of context." Whitehurst concluded for Falwell by claiming, "we've not been to court or

even [been] invited to do so. Although it is every expensive to fight this type of harassment, we shall certainly do so."

Sloan disputed Falwell's claim of not being invited to the trial. Sloan said Falwell did not attend the trial, but that attorneys for both sides were jockeying for trial dates. "So he had to be very aware of what was going on."

Ullman's decision represented a personal triumph for the 48-year-old Sloan. He pointed out that this was the first time Falwell, "has been held accountable in a court of law for what he has said." The triumph was also personal for Sloan, however. In 1955-56, Sloan and Falwell were classmates and friends at Baptist Bible College in Springfield, Missouri.

"He was ambitious, outspoken and zealous," Sloan remembered. "He was the fair-headed boy of that school." Sloan said Falwell was able to get a job in a Kansas City church which Sloan attended. "Jerry and I used to be on the road, driving to Kansas City quite a lot," said Sloan.

As for now, though, Sloan has a very definite opinion of Falwell. "The man has no shame," he said.

## Rock Hudson's ashes spread over Pacific

LOS ANGELES, CA (AP) - The ashes of Rock Hudson, who died Oct. 2 after a year-long battle with AIDS, were scattered in the Pacific Ocean, a mortuary spokeswoman said last Saturday.

"The ashes have been scattered in the ocean," said Beth Burr, spokeswoman for Pierce-Hamrock-Reed Mortuary in North Hollywood. She said she couldn't provide the exact date, but "it was within the last few days."

The body of the 59-year-old Hudson, who battled the ravages of acquired immune deficiency syndrome for more than a year, was cremated shortly after his death. Burr said she turned Hudson's ashes over to an "authorized person" whom she declined to identify.

Chen Sam, a New York Publicist for Hudson's friend, actress Elizabeth Taylor, has said Hudson's friends will gather at his home for a memorial.

### GAYS' JAIL UNIFORM PROTESTED

DENVER, CO (AP) - Prisoners in the Denver County Jail wear green if they're awaiting trial on felony charges and blue if they're accused of misdemeanors. Homosexuals, in a policy assailed by Gay activists as 'repulsive', wear gray.

The gray uniforms are also issued to prisoners who have histories of violence or psychological problems, officials say, adding that the color coding allows guards to identify inmates in the wrong place.

In addition, according to inmate service program director Ted Peak, the uniforms help guards protect homosexuals, who, he said, should be separate from other prisoners to prevent assaults.

Gay rights groups have assailed the policy, which has been in effect more than a year, saying it unfairly singles out inmates and could create more tension in an already rough environment.

service this Saturday, Oct. 19. She said invitations were sent to about 150 people. "Everybody that's invited will have the opportunity to express their feelings," she said, adding the service is to be carried out according to directions left by Hudson.

Hudson's last appearance before the camera was during a taping of the Christian Broadcasting Network show with his former leading lady Doris Day, with whom he starred in the 1950's and early 1960's comedies such as Pillow Talk. Hudson taped the show July 15 in Carmel, about 270 miles north of Los Angeles, after agreeing to appear to help her with a segment of the program "Doris Day's Best Friends".

"It was heartbreaking," Day said in a prepared statement. "He didn't say anything about his illness, only that he had been suffering with the flu and it had caused him to lose weight. Day said she told Hudson not to worry about working that day, but 'He wouldn't hear of it. 'Forget it,' he said. 'I came up here to work with you again and that's exactly what I intend to do.'"

Hudson, whose image was that of a rugged leading man, drew acclaim for his disclosure that he was battling AIDS, which cripples the body's immune system, leaving its victims vulnerable to death from a variety of infections and cancers. There is no cure.

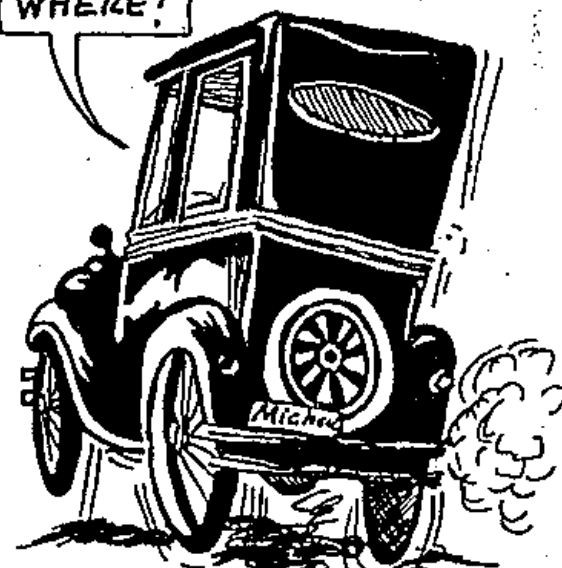

of the policy and procedures section of the disability branch at Social Security told the Bay Area Reporter, "We have no formal policy at this time on AIDS related conditions." Shiels added that "this was because there is no national medical definition of ARC." "It certainly is a concern to the agency," Shiels said, "because we are working right now on putting something in place in relation to AIDS-related conditions. Certainly a person with ARC is not someone who is going to be denied disability. The way we evaluate claims is based on the severity of the disability rather than the diagnosis."

Shiels reiterated that Social Security needs a definition of ARC. And she stressed that each case is looked at individually. Then she added again that Social Security is working now on guidelines for ARC claims. "The kind of conversation you and I are having now," Shiels noted, "is the kind we should have had three years ago or so on AIDS."

### TRYING AGAIN [PART 1]

Have you ever thought back to a former love with a lot of regrets? It happens. Do you ever toy with the idea of trying to get it all back together again? What a silly idea!.. Is it? Is it a silly idea to think about the possibility of trying again? No, it is not and it is something that people need to give some thought to. Over the next few weeks that's exactly what I'll be dealing with, trying to get it all back together again. The fears, the ups and downs, unrealistic ideas and expectations, work, pitfalls, negotiation and if all seems 'go' then the actual doing it.

There are a lot of fears connected with trying again. What will everyone say or think? Will they laugh? Public opinion is a factor. If things don't work out the second time, a lot of tongues will be wagging to be sure. No one wants to face failure a second time, let alone the first. People become such pro's with their I-told-you-so and I-knew-it-would-never-work. Wouldn't it be nice to have people saying, "Peter and Jack are going to try it again, let's be sure to give them all the encouragement we can." In the end analysis, who's going to have to live with the if-onlies? You, and no one else. So... who cares what everyone thinks anyway. If the opportunity presents itself and you pass it up, will it present itself again? Chances are no. It would be a sad thing to have to live with years down the road to find that the other party was thinking about the same thing, but didn't get any encouraging signals.

Making the decision to give the idea serious consideration would also be foolish without getting some professional counseling to help you see things in a proper perspective. If one is serious then this is the time to go about things in the proper way - not half-cocked. Some people even think that a cock handled correctly can cure all ills. If you haven't learned the fallacy of that, then you might as well forget it now and not waste time and money. Sex is a big part of any relationship. I would not deny that, but it is two persons and how they relate or don't relate that we're dealing with.

Failure, even with help, maybe that will be the result. Who's failure is it then? It's not yours if you've looked at everything and given yourself to it. Any guilt on your part is release. You can live with the fact that you tried and go on with your life. Another thing to think about is, is it failure when two people find they are not suited to each other and the blinding factor of love wasn't really there in the first place? No, it's just being honest with yourself.

This process of seeing if it's possible to put it back together again takes honesty. It means being able to take some hard, honest looks at ones self as well as others. There will be pain in it. Put very simply, there is a lot of work involved, emotional work. Either way, the end result will produce a better you.

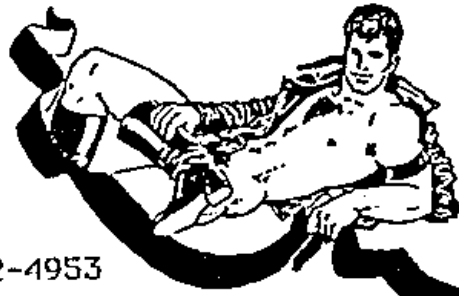

## A View From Within

by Christopher Geoffrey McPherson

NEWTON DEITER, ON HIS WORK FOR THE TELEVISION  
SHOW DYNASTY,  
AND COMMENTS ON THE GAY CHARACTER, STEVEN.

[Part two of three]

"The overwhelming majority of what we see on television [is] not about us, it's about how other people react to our homosexuality.... The thing that DYNASTY has done is... certainly we see a lot of reaction because after all that creates drama and that's what television is all about."

Yes, that is what television is all about, but the media of television and the effects it has on the community is much farther reaching than that.

"We [Mr. Deiter, Richard and Esther Shapiro, the show's producers] are going to take all of America... along on Steven's journey. And in so doing, we were going to piss-off a whole bunch of people."

This is what television is all about....

I was privileged to be granted an interview with Mr. Newton Deiter, who is a free-lance consultant with Aaron Spelling Productions, and has done a great deal of work with the producers on the character of Steven Carrington.

The original conception was Esther and Richard Shapiro's, and about one year before we were all given DYNASTY, they asked Mr. Deiter to consult to them about properly portraying Steven. Mr. Deiter, who is a psychologist and who helped found the Gay Media Task Force, is no stranger to the field of consultation. He also did some work for the City of Los Angeles, and has helped with the production of such shows as HOLLYWOOD BEAT, BARNEY MILLER, and many other television shows including an episode of LOU GRANT, and many movies including, Dawn, The Story of a Teenage Runaway, and Alexander: The Other Side of Dawn.

I asked him about the original characterization of Steven. I said that he seemed to be lost. "Lost is a good word -- he was."

"The overall goal of Steven trying a lot of things, and making a lot of mistakes, and going through self-denial and very slowly and gradually coming to grips with his being Gay including a period of marriage and bi-sexuality that he tried to run away from: all of these things... [are what the Shapiros -- as producers -- envisioned in the creation of the character of Steven]."

"At the same time, we see Steven going through an agonizingly slow change and growth of his values as he re-evaluates his life at different points. We see him making mistakes, and we see him seeking what's right for him. [This has been] happening slowly and gradually as it does in real life, instead of just with a thunderclap of revelation."

"He [Steven] discovered an interesting thing [about being Gay] that many of us discover. One can get it up for a woman, but it doesn't mean that one is heterosexual.... One can even love a woman, but it doesn't mean that one is heterosexual."

Mr. Deiter stated that Steven's marriage to Sammy Jo [who is also the mother of his son] was an overreaction to Ted's death. [Ted was his first lover in the first season who was killed by Steven's father, Blake].

On the marriage of Steven to Claudia: "Steven tried to conform... in a... mature way, but what he discovered was that he could not conform. [And Luke Fuller] was how he discovered he could not conform."

When I asked about the reason for Luke's death [which I theorized in my 29 May 1985 column was due to censor pressure], Mr. Deiter said: "The actor [Bill Campbell] did not want to renew his contract." [Too simple].

When asked about the rumor that George Hamilton's new character would be Steven's new love: "No comment. I am not permitted to comment on anything that's going to happen this season."

He added: "Keep watching. I don't think you'll be disappointed if you hang in with us. I can't say anything more than that -- my lips are sealed."

I asked him about AIDS, and whether DYNASTY would deal with this crucial subject: "I can't really answer your question without going into plot lines that we've discussed, so I really have to pass." He added: "Steven is not going to die of AIDS."

Although I could not pry any secrets from Mr. Deiter, he did say that throughout at least part of the season's 27 episodes, Steven would be reacting to Luke's death: "Steven right now... is suffering over Luke's death. His grieving is going to be very, very apparent. Out of that grief and attempting to assuage it, he's going to do what many people do: he's going to throw himself into his work and into his responsibilities. But, it's a long season."

Before my interesting interview ended, I asked Mr. Deiter about whether there is any need for a Gay consultant on the DYNASTY spin-off DYNASTY II: The Colbys of California. His [as usual] reply? "Yes, and I can make no comment beyond that."
