Republicans join Pima County Demo Committee ask Mecham to quit

And the beat goes on.....

The Governor took off for Taiwan this morning for a weeks stay there and in Japan, officially opening a trade office in Taipei. Wonderful.

Meanwhile at home, turmoil, toll and trouble for the governor.

The state Democratic Party is considering the endorsement of the recall movement. There is a meeting of Pima County precinct committeemen this Saturday, Oct. 10, John Kromko, Pima County Democratic Party Chairman said. State Democratic Chairman Sam Goddard has sent a letter personally asking for the resignation of Gov. Mecham. Two Tucson Republican legislators have called for the resignation.

All this as a result of the idiotic, homophobic letter the Governor sent out to ultra-right conservatives throughout the country as reported last week.

"I think the situation is hopeless," said Robert Stash the Pima County Republican Chairman. "I think the governor has made it difficult for all of us to remain loyal Republicans. The situation is bad and is getting worse," he said. When asked if the GOP would ask Mecham to resign, Stash said that there was a possibility.

There will be a new signa-

ture count this week. At presstime, OBSERVER learned that the Pima County total as of last Monday night, Oct. 5, the local recall office had counted 63,230 signatures on petitions gathered in Pima County.

As reported in our September 15 issue, the local office had collected 38,240. The new figure shows an increase of nearly 25,000 signatures in 20 days! The local office has raised their goal total from 66,500 signatures to 80,000.

There has been a lot of talk concerning the validity of signatures. Charges of fraud are coming from both sides of the recall movement. A press release from Ed Buck, Founder of the recall effort, said that fraud charges have been made regarding the signing of recall petitions, and that those charges have been made by Mr. Ron Bellus, an entitled functionary from the Governor's office.

Mr. Bellus told Tamara Jones, a reporter for the Los Angeles Times that he knew of forgeries. Mr. Bellus told Jones that he knows of one worker in the recall camp (whom he refused to name) quit because she saw other workers forging signatures.

In addition, Bellus said several Mecham supporters have boasted that they personally signed

Jesse Jackson to address National March Rally

WASHINGTON, DC (Blade) - The Rev. Jesse Jackson, Democratic presidential hopeful, will speak at the October 11 National March on Washington for Lesbian and Gay Rights, March leaders have announced.

March organizers say they believe Jackson's appearance as a speaker during the March will also raise Gay rights as an issue in the upcoming presidential primaries. "We consider this a major development," said Kay Ostberg, co-chair of the March.

Organizers of the October 11 event are predicting that at least 100,000 people will attend the March, which is scheduled to travel from the Washington Monument past the White House to the Capitol. Following the March, a rally at which Jackson and others are scheduled to speak will be held on the west grounds of the Capitol.

In endorsing the March, Jackson said, "On October 11th an historic gathering will occur in Washington, D.C. Hundreds of thousands of people will march through the streets of our nation's capital, demanding full rights for lesbians and gay men, and an end to discrimination against all those with AIDS and related conditions."

"I endorse the March on Washington for Lesbian and Gay Rights. The National March is an important opportunity to gather all people who support basic human rights," he said.

Jackson continued, "The March is an opportunity to call serious attention to the biggest health care crisis in our country - and perhaps the world. Our nation must admit the facts: that AIDS has already struck over 35,000 in the U.S., 25 percent of whom are black, and 14 percent Hispanic; that 3,000 babies have been born with AIDS, of whom 90 percent are black. The facts are that AIDS can strike at any one of us. While Gay men have borne the initial burden of AIDS - and have responded in exemplary ways - AIDS is not a Gay disease. It knows no boundaries of race, class, sex, age or sexual orientation."

"All those concerned with social justice and all those who understand the rights of all of us are bound up with the rights of any one of us must join us in Washington, D.C. on October 11th as we March on Washington for Lesbian and Gay Rights," Jackson concluded.

March organizers also announced that actress Whoopie Goldberg will join Jackson as a speaker at the rally. Frank Piazza, Goldberg's West Coast publicist, said Goldberg is "completely supportive" of the March and its goals. He said Goldberg, who was nominated for an Academy Award for her role in the film "The Color Purple", plans to appear at several March-related events, including a ceremony to assemble

thousands of quilt panels bearing the names of persons who have died of AIDS.

March leaders said Jackson was the only presidential candidate to be invited as a speaker. The leaders stress, however, that Jackson was invited because of his role as a national civil rights leader, not because he is a candidate for the presidency.

"We never intended to invite presidential candidates," said Ostberg. "Our intention was to invite a civil rights leader, a labor leader, and a women's rights leader."

Ostberg said the March invited farm labor organizer Cesar Chavez to be the labor speaker and former National Organization for Women President Eleanor Smeal to be the women's rights speaker. Both accepted the invitations.

Gil Gerald, former executive director of the National Coalition of Black Lesbian and Gays and a member of the March steering committee, said Jackson, as much as anyone in the nation, is viewed as a prominent civil rights leader.

"We consider the March an important civil rights event," Gerald said. "The Rev. Jackson's involvement in the civil rights movement provides an important link between the movement of Martin Luther King Jr. and the movement for Gay and Lesbian rights," Gerald said.

March officials say Jackson's strong statements on AIDS in recent months provided additional grounds for inviting him.

Jackson devoted a full 30-minute speech to AIDS on May 13, when he addressed an audience at Northeastern University in Massachusetts.

In that speech, Jackson called for stepped-up efforts by the federal government in AIDS research and AIDS education programs. He then issued a stinging attack against conservative and religious leaders who have opposed on moral grounds AIDS education programs in the schools.

"In their racist and homophobic bigotry," Jackson said of the critics of the education programs, "they would end the lives of hundreds of thousands, Gay and straight, black and white." "In their determination to control the moral climate of this nation," Jackson added, "they threaten the lives of us all."

March leaders say long-time national Gay rights leader Virginia Apuzzo will also be among the other speakers at the March rally. The rally will also include entertainment by Lesbian and Gay performers, including comedy acts, vocalists, choral groups, and bands, Ostberg said.

Jackson is expected to announce

POST OFFICE INTERFERES WITH AIDS INFO

SAN FRANCISCO, CA - The Harvey Milk Lesbian and Gay Democratic Club has had hundreds of pieces of mail returned as "unmailable" by the U.S. Postal Service, with the postage cancelled and the material marked up beyond re-usability because of an obscure technicality which the Post Office itself does not follow - except when the mail in question is material about AIDS.

Citing regulations which require international mail sent to Spanish-speaking countries to bear the words "Par Avion" instead of "Air Mail," the San Francisco Postmaster's office rejected the mailed brochures; however a survey of 11 post offices in San Francisco revealed that none of them had a "par Avion" stamp and postal workers routinely substituted the words "Air Mail" instead.

"Outfront" magazine quoted David Lewis, director of the Harvey Milk AIDS Education Fund, saying "This is just the latest example of a long history of tampering with our mail and abusing Postal Service Policies."

3RD ANNUAL CONFERENCE OF LESBIANS/GAYS IN PUBLIC OFFICE COMING UP IN NOVEMBER

MINNEAPOLIS, MN - Gay men and Lesbians who hold or aspire to public office will gather in Minneapolis/St. Paul, Minnesota, the weekend of Nov. 20-22 for the third annual conference. The Twin Cities Conference will draw Americans, Canadians and Britons for a non-partisan gathering focusing on the mutual concerns and experiences of Lesbian/Gay elected and appointed officials, candidates, potential candidates, campaign workers, and their life partners.

The Twin Cities Conference follows predecessors in West Hollywood (1985) and Washington, DC (1986). Like those earlier gatherings, it will allow Gay men and Lesbians from the arena of public office the opportunity to meet and share their experiences, particularly regarding the expectations and realities of Gay/Lesbian public officials. In addition, conference attendees and leaders of national Gay political organizations will discuss and strategize around topics of concern to our communities, such as AIDS, civil rights, the 1988 U.S. presidential race, sodomy repeal, violence, and family law.

Keynote speakers for the conference include Chris Smith, a Labor member of the British Parliament; Ginny Apuzzo, New York State's deputy commissioner of consumer affairs; and Harry Britt, of the San Francisco Board of Supervisors.

The Twin Cities of Minneapolis/St. Paul have been particularly successful since the mid-1970s in electing and re-electing open Gays and Lesbians to public office. In addition, a number have been appointed to various boards and commissions. Local hosts for this conference include Gay/Lesbian Minnesota Rep. Karen Clark; Minneapolis Council Member Brian Coyle; Minneapolis Civil Rights Director Emma Hixson, and Minnesota Senator Allan Spear.

VIRGINIA USED TO BE FOR LOVERS

RICHMOND, VA - The Virginia State Board of Health has proposed that HIV-positive individuals be reported to state health officials and that their sexual partners should be traced and notified. The Washington Blade reports that Virginia Health Board Chair, Dr. A. Carole Pratt says "AIDS should be treated as any other communicable disease - the contacts of those who are infected should be notified that they could be at risk." Pratt added that "every effort would be made" to keep confidential the records of those testing positive.



Clinging to Bork's extreme right-wing record and past inactivity to civil rights/civil liberties issues, a broad cross-section of civil rights and women's groups have pledged to oppose him. They argue his confirmation could tip the Court balance and lead to erosion of past civil rights gains.

Advocates of lesbian/gay rights point to his record of opposition to gay protection. One of his best known opinions states: "Private, consensual homosexual conduct is not constitutionally protected." He described arguments of pro-Lesbian advocates as "completely frivolous."

Activists point to high stakes. The Court will not only address privacy and gay employment cases, but critical cases relating to the AIDS crisis. Gay lobbying groups have joined the coalition opposing Bork's confirmation. But they need our help! One civil rights leader said, "There's no question the mobilization of the grassroots is one of our most critical tasks."

San Francisco jury awards \$2.8 million in same-sex palimony suit

SAN FRANCISCO, CA (Sentinel) - Jim Short made national legal history last week when a San Francisco jury awarded him a total of \$2.8 million in the nation's first successful same-sex lawsuit.

The jury's verdict was unanimous in awarding the 57-year-old clerk at First Interstate Bank \$1.785 million in compensatory damages and \$500,000 in punitive damages for breach of an oral contract.

"Money cannot buy happiness, but I am entitled to what is rightfully mine," said Short, reacting to his victory during an interview with the Sentinel. Short sued his partner of 19 years, real estate developer Charles Gale, after he refused to share their joint investments following a breakup in 1983.

Short's attorney, Arthur McGlendon, Jr., argued that the couple had verbally agreed to "share their lives together and everything they acquired." McGlendon further contended that the intent of the partners appeared clear in the fact that wills existed in which both men left their estates to the surviving partner.

So why was nothing put in writing? "We were proud in 1964 that we could have won our union unbound by a piece of paper," said Short. "We felt this put us above the straight marriages. With us, no signed agreement was necessary. Of course, a 'Gay marriage' or union in 1964 would have been unthinkable. We were very closeted and went to great pains to conceal our relationship outside of a few close friends," remembered Short.

Following his recent experience with Gale, Short now advises other Lesbian/Gay couples to "think about making arrangements while you're living and not just a will in case of the death of your

partner. "Short realizes that it may be difficult for partners to sign written agreements because one partner may see it as an implication that someday there may be a breakup. "It's just being realistic. Making such a written agreement in case of separation would have raised eyebrows in the '60s, but not today, contends Short.

The trial was difficult for Short, who frequently wept openly during the proceedings. "It was hard to see our friends divide up and testify against one another," said an emotional Short. "This trial also brought us out of the closet. I'm just glad there was little publicity during the proceedings, and the case was not tried daily in the newspapers."

Short looks forward to the future with mixed emotions. "My experience with Gale was rewarding for so many years. It's been difficult. Now we are two middle-aged men who may grow old alone. We broke an empire in half and ended a relationship of almost 20 years. While I'm glad the ordeal of the trial is over, there is not much to celebrate. I can enjoy life without all of that money."

Short has not soured on loving couples establishing relationships. "I urge others to enter into relationships and to work to sustain them with or without agreements. I encourage people to get together and stay together. I certainly hope that my case would not encourage others to end their relationships just to go to court."

Since breaking up with Gale four years ago, Short says he has begun to develop some new friendships, but finds "ageism" in singles bars awkward. "It's been difficult," said Short. "Remember, I slept with the same man for 19 years."

At the time Short and Gale parted, they had a home in Pacific

Heights and a weekend retreat in San Rafael. Their total real estate assets were estimated at 3.5 million dollars. However, there were no written agreements between the couple and when Gale, who had almost all the property in his name, refused to divide the assets, Short took the matter to court.

During the course of the trial, the jurors heard that Short had contributed to the household expenses while first running a beauty parlor and later working for a lumber company. While Gale owned property when the couple met, Short says, "We accumulated a great deal together, and we were strapped to make payments. My income was often all we had as a steady income."

"When we started, gasoline was 27 cents a gallon and bacon was 59 cents a pound. You cannot buy groceries at Safeway with equity. We never had money because we were always investing."

Short praises Gale for being "very clever" in manipulating notes, loans and transfers of Bay Area properties, but adds, "It was also 19 years of sacrifice by me; it (accumulating property) became my total effort. I never even got a personal Christmas present as everything was for the house. For so long, we were broke - and then suddenly - in 5 or 6 years in the 1970s, inflation began and our properties became very valuable. Our Pacific Heights townhouse that we bought of \$68,000 is now worth \$1 million."

The couple had little money for travel for most of their years together. They bought a boat, Short says, "and our 'trips' consisted of going up the Delta and tying the boat to a tree for a few days. So much of our time was spent accumulating assets, I had my doubts when times were rough. But it turned out to be the wise thing to do."

While the couple did little traveling, they enjoyed inviting friends in for dinner and cocktail parties - musicians played in the background in more recent years. When personal problems between the partners surfaced in 1983, the two consulted a counselor. The attempt failed, and the relationship ended in bitterness. Short claims Gale told him, "I want to see you on the street with just a shopping bag." No financial settlement could be reached, and Short went to court.

Gale would not comment on the trial, but his attorney, Valerie Karpman, said her client was "mortified" by the decision. She told the Sentinel, "This is not a palimony case at all. It is not even a Gay or straight matter. The issue is that there has to be a contract between business partners and there was none. There were no joint bank accounts, and Mr. Gale's business was his own. This was not a joint venture contract."

She denied that Gale had been unemployed for six years, as Short claims, and says Short was wrong to assume that because they were lovers he also was entitled to half of Gale's business. Karpman insists, "He only contributed to household expenses. It was Gale who owned the property, bought the medical insurances, the boats, properties, everything."

Short would like to avoid another trial, although Karpman is expected to appeal. He explains, "My ex-lover did not say 'Oops!' and write a check. He said 'I'll not give up. I would still an out-of-court settlement."



As I See It

There's been a bit of a flap going on at the UofA which most Tucsonans probably know little or nothing about. It involves the Fineline bar, the Wildcat newspaper and a group of upset students, faculty and staff members.

In a recent ad, prominently displayed in the Wildcat, the student-run UofA newspaper, the following wording appeared in mid-September.

"Tucson's only progressive dance club, the Fineline is a straight club... if that offends you - please stay out."

The ad ran one day and raised such an outcry of protest from students, faculty and staff all claiming "discrimination" that the Wildcat pulled the ad and agreed that if the issue had been Black and White instead of Gay and Straight, they would never have run the ad in the first place.

Some years ago, another Gay bar attempted, albeit briefly, to go "straight". Without knowing what was going on that week, I drove into the parking lot of the Joshua Tree/Back Pocket one Tuesday night with some out-of-town friends for an after dinner drink. We were met at the door with a sign and a bouncer both saying that "Gays are no longer welcome here." By the next weekend, the bar was back to catering primarily to Gays again. But I haven't been back since that Tuesday night; if I wasn't welcome on that night, my sense of Gay pride tells me I'm not welcome at other times either.

There are lots of issues involved in both of these situations. When a bar owner, trying to rekindle interest in and incomes from his/her bar, decides

to "go straight" the chance to offend old friends and customers is great. The platitudes uttered in the past may acquiesce to the realities of an empty cash register. And often quoted statements of Gay pride and Gay acceptance may get buried in an avalanche of anger, frustration and homophobia.

Indeed, there is the reality that the bar owner needs to make a living from the bar; they cannot go on for long running a "charity". None-the-less it seems to me that being insensitive to former customers, whenever they are, telling them that they are not welcome, or at minimum, not as welcome as they had been welcomed before, is offensive to anyone and a slap in the face to everyone. By mentioning the fact that the bar is now straight, the statement itself becomes discriminatory unless great care is taken in its phrasing.

As I see it, it's particularly offensive when the matter involves a Gay or Lesbian business, owned by Gays or Lesbians and others who have been actively involved in the Gay and Lesbian communities, for they should know better. Discrimination and homophobia is bad enough when inflicted from outside our community, I find it particularly appalling when it happens within.

We cannot expect those outside of our community to understand the issues and be sensitive to our cries of hurt until we inside the community are willing to meet those minimum standards ourselves. Homophobia is as wrong inside our community as it is from outside.

I ran an ad in your newspaper which simply states, THE FINELINE IS A STRAIGHT BAR... IF THIS OFFENDS YOU PLEASE STAY OUT. Because of a single letter signed by five people who call themselves "The Gay Literary Guild" (a name I have never heard of in my seven Gay years in Tucson), out of 33,000 students you have publicly stated you will not run my ad again because the Daily Wildcat has a non-discrimination policy. You have not explained why you believe our ad discriminates against Gays. The ad very plainly states "IF THIS OFFENDS YOU - PLEASE STAY OUT".

You and the "Guild" have assumed we mean Gays stay out. Not true. I really did not believe anyone would be offended and to date you are the only ones who are. Incidentally, we checked with the university and could not locate any organization under the name of "THE GAY LITERARY GUILD".

Since Gays frequent most all bars in Tucson, Gay and Straight, I cannot see where anyone would be offended. We do not now, nor have we ever asked anyone their sexual preference in order to gain entrance in our establishment. Our business is providing a good fun time and make a profit, money has no sexual preference.

You seem to be more upset because a Gay bar has turned straight. A bar you have not been into in three years by your own admission. We are a marvelous bar with a place for everybody. Just as our poster states. However, we wanted to alert everyone to the change, to inform both the straight and the Gay community that we are no longer a Gay oriented bar. The Arizona Star and the Tucson Citizen previously referred to the Fineline as a dance bar with a predominantly Gay clientele. Now we want everyone to know this is no longer true and everyone should conduct themselves as they would in any straight bar.

The point is, we must tell our story. You as a newperson should know that sometimes it is necessary to use shock value to make people take notice. I do not believe you as editor has the right to refuse my legitimate advertising or force me to change my copy because of your prejudice against my bar. You stated in your phone conversation with us that it was not a legal question but a personal one.

I remember in the 1940's when Hitler discriminated by burning books and controlling newspapers. I think you as editor should address your own conscience as to who is really discriminating. It is frightening that one editor and five people who belong to an unknown organization as "THE GAY LITERARY GUILD" can wield so much power.

Newspapers use editorial pages for their editors views, not their power to squash legitimate advertising because of those views. This is an interference with my right to do business. I find your actions as a newspaper editor shocking, especially during this 200th anniversary of the Constitution and it's 1st Amendment. Sincerely yours

bogus names to several recall petitions, which would be questioned and thrown out during the validation process. Bellus told Keith Bagwell of the Arizona Daily Star that people who support Governor Mecham also have signed phony signatures on petitions in an attempt to sabotage the recall drive. Bellus also said, "A guy who supports the governor told the Mecham camp he had signed 10 bogus names."

It might be pointed out that signing a bogus name to a recall petition is a Class 1 misdemeanor, punishable by up to 6 months in jail, a \$1,000 fine. Forgery is a Class 4 felony. The Mecham Recall Committee, through a press release issued by Ed Buck has demanded that Mr. Bellus step forward with the information that will lead to the arrest and prosecution of anyone who has violated ARS 19-206 (B). "Failure to do so would lead one to believe that Mr. Bellus is either fabricating a story or guilty of obstruction of justice and criminal complicity," the release said.

THE RECALL: THE FINAL CHAPTER

The governor is finally taking the Recall seriously. Hiring a \$62,000 Media consultant, raising \$108,000 to send out a tabloid, spending \$10,000 on TV commercials for Republican hired guns to tell you why Evan should stay and the final assault the 25,000 letters asking for \$1.2 million to keep from being crushed by the "militant liberals and the homosexual lobby".

In spite of all of this, the Recall is reaching a point of being a smashing success and Mr. Mecham is being confronted with the option of resignation. As the Recall moves into the last 30 days, more help is needed than ever before. The group has set a goal of 350,000 signatures on petitions before the Nov. 3 deadline. If you have not signed, or if you know of anyone who has not signed the petition and wants to do so, come by the Tucson office 2625 E. Speedway or call 881-7707.

If you have a petition that has been signed (even with only one signature), and you are not going to gather any more signatures, make sure that that petition gets to the Tucson Recall Office as soon as possible. Every signature is important!

The Recall Committee is, of course, in need of monetary donations. They need small donations (\$20-\$25), to counteract the flood of Mecham money, and to see the petitioning, review and submission process through to Nov. 3. Volunteers are also needed to do part-time office work as well as petition signatures.

In Tucson, Friday, Oct. 16 there will be a fund raising event. Called the "Adios Mecham Fiesta", the Recall benefit will be held at 2223 E. Edison. Tickets for the event which runs from 5:30 to 7:30 will feature several local politicians and Mecham Recall Committee President Garry Smith as well as several other people from the Phoenix office. Recall Founder Ed Buck will be there, appointments permitting. There will be entertainment. Tickets are \$20 each and are available at the Tucson Recall office.

Kronko has called for an Oct. 10 convention of Democratic precinct committeemen to vote on endorsing the recall movement. The Democratic leaders have vowed not to become directly involved in the recall effort. But "that situation has changed dramatically. The letter was the last straw," Kronko, a state representative said. "I just decided it's not right for us to stay out of this anymore."

Kronko said he received permission from the State Democratic party to proceed with the convention. At least eight Republicans came into Pima County Democratic headquarters one day last week to switch party affiliation, Kronko added.

Until now, the Democratic Party wanted to stay neutral because supporting it might damage the drive by making it appear to be a partisan issue. Democrats also felt that as long as Mecham were in office, his actions would benefit the Democrats in the long run.

"But we can't hurt the recall. There is going to be a recall election," Kronko said.

Ed Buck said, "Here we have a case of politicians responding to cold, hard reality." "Mecham has lost not only the confidence of the state but of those Republicans he works with," he said.

"The Republican Party will be dragged down with Evan Mecham," Buck said Mecham should resign to save the state money and further embarrassment.

The Pima County Convention of Democratic precinct committee representatives will be held at the Plumbers and Steam Fitters Hall 2475 E. Water Street at 10:00 a.m. this Saturday, Oct. 10.

Senate Judiciary votes Bork down

WASHINGTON, DC - The Senate Judiciary Committee has voted no on the nomination of Judge Robert Bork to be appointed to the U.S. Supreme Court. In a 9 to 5 vote held Tuesday, Oct. 6, the Committee turned thumbs down on Bork's nomination. The nomination now goes to the Senate floor where the full Senate will vote on the nomination.

Arizona Democratic Senator Dennis DeConcini voted against the nomination. Our other Arizona Senator, Republican John McCain voted for the nomination. An avalanche of mail and telegrams have been deluging senators' offices regarding this nomination both pro and con.

As of presstime, President Reagan vows he will continue the fight to get Bork nominated and Bork, himself, shows no proclivity to bow out of the nomination. The full Senate countdown shows that Bork Opponents number 36; Bork supporters number 32 and there are 32 uncommitted Senators. Usually the Senate follows the Judicial Committee rulings, but with such pressure pro and con on the uncommitted Senators, the nomination could still go either way, although many politicians give Bork little chance of getting the nomination. The pressure must be kept on until Bork's nomination is defeated by the full Senate.

In a late press release the Human Rights Campaign Fund urges the rejection of the nomination of Judge Bork. "Bork's record is that of an anti-civil libertarian, who would deny Constitutional protections to the Gay community," said Vic Basile, Campaign Fund Executive Director.

"Judge Bork's record suggests he would move the law of the land sharply to the right on issues like homosexual rights..." said the New York Times the day after his nomination.

Judge Bork's record hold no ambiguity.

In *Dronenburg v. Zech*, a 1984 decision upholding the U.S. Navy's right to discharge an en-

A Sexual Community Learns New Games

At the recent Lesbian and Gay health conference in Los Angeles, many longtime AIDS activists were surprised by the extent to which safe sex education has become the province of the high level professional. The fact that safe sex organizing began and is highly successful as a grass-roots community effort seemed to be forgotten. It was as if the professionals had invented safe sex. Although professional health and sex educators have made important contributions to AIDS education, their work came long after a community under siege had mobilized to protect itself.

The over-professionalization of safe sex organizing - and the lack of historical insight by professionals - has a direct effect on the style of education for Gay men, and recently heterosexuals. Many Lesbians and Gay men just laughed at the silly pronouncements of Reagan's officials, but there is a hidden price to this smugness. Innovative programs such as one that trained bartenders as educators, and rap actions where leather-clad men raided bars and passed out condoms, have fallen by the wayside. Most educators are no longer willing to take social risks in order to promote sexual safety.

We must not lose sight of the history of our organizing, or allow our successes to be counted by professionals who came late to the health crisis. If we embrace a revised history in which professionals imagine that they conjured safe sex out of formulas and studies, we will become dependent for information from the medical establishments that is so callous toward Lesbian and Gay health concerns.

We should count as our victory, the largely successful efforts to make safe sex a norm in our community. Although there are more sexual practice changes needed, we should be proud of what we have done for ourselves, and continue to work for both sexual freedom and sexual health.

"HOW TO HAVE SEX IN AN EPIDEMIC"

Safe sex organizing began almost as soon as AIDS was recognized. Organizing within the Gay community started as a reaction to the sensational, blaming and anti-sex pronouncements of doctors ignorant about Gay male sexuality. Their advice assumed that all Gay men did the same thing, or that any individual Gay man did only one of a set of practices - for example that a man was exclusively the object of anal sex, or only oral sex.

Badly designed studies and homophobia combined to create a flurry of nonsensical, insulting advice. At the 1985 International AIDS Conference in Atlanta, for example, a CDC official proposed that all Gay men take the then-new HIV-III antibody test. His suggestion that Gay men have sex only with men of the same antibody status characterized Gay male culture as a giant dating service. Gay men quickly came up with their own advice, and coined the term "safe sex". Sorting through the same data, and adding knowledge about other STDs among Gay men, activists created safe sex guidelines even before a virus was identified.

By May, 1983, so much material about safe sex had been distributed through clinics and in the Gay press that a group of men - including men with AIDS - produced a 40-page pamphlet called "How to Have Sex in an Epidemic." This still stands as one of the single best, most comprehensive explanations of transmission models, safe sex and psycho/social guidelines for effecting risk reduction.

Considerable controversy surrounded the publication of this booklet, foreshadowing the political struggles which have engaged sex educators and community activists throughout the crisis. Two principle criticisms emerged: some thought the only sound advice was to advocate celibacy, while others thought it irresponsible to offer specific advice until there was a certainty about the transmission and cause of the disease.

The celibacy argument is still being promoted by rightists, and will continue to affect public policy and federally funded education. In addition to right-wing homophobes, many Gay AIDS activists are willing to advocate celibacy for at least some people, notably Gay youth.

The second objection - when is it responsible to give advice? - has been played out in strange ways. The inability to decide in detail what is safe and unsafe has prevented numerous organizations from recommending what is safe in broad terms. At one point, Gay Men's Health Crisis, the New York AIDS group, could not agree on what was safe and, for nearly a year after its first round of safe sex publications, could not approve any new material.

SAFE, SAFER, SAFEST?

Counselors and safe sex educators, especially doctors, are often unwilling to say that anything is safe. They say they are afraid to take responsibility for telling someone that "X" is safe and then discovering the person got AIDS. This mixed message leaves people confused about what is unsafe, and gives an underlying impression that nothing is truly safe, and therefore everything is equally unsafe. This is a troublesome misperception: studies of changes among Gay men showed that changes early in the epidemic were based on a perceived need to change and subsequent reduction in the least favorite activities, rather than changes based on a real hierarchy of risk. Ironically, a different attitude is now taken in educating youth: a project in New York City advocates telling youth that unprotected anal and vaginal sex are absolutely unsafe, and if youth feel they can give up only one thing, that is the thing to give up.

The early guidelines by grassroots organizers were sensible, logical and based on good epidemiological model generated by Gay men with an understanding of the range of sexual behaviors in their community. It remains solid advice. But many people, including leaders in AIDS organizations, were uncomfortable with this advice until doctors lent their stamp of approval.

Condoms in particular were a source of equivocation. The Federal Government is largely culpable here: they refused to fund or direct research on the efficacy of condoms. Even after the virus was identified, they said technology did not exist to test condoms. Finally, last summer, some California researchers constructed an ingenious device consisting of plungers to which condoms could be attached. Their study showed that even under extremes to which they subjected condoms, no virus leaked through the latex.

Now suddenly, condoms have become a panacea for sexually active heterosexuals.

"WHATEVER YOU WANT TO DO, YOU CAN PROBABLY DO IT SAFELY"

It has been hard for many people to hear the safe sex message. Despite the best intentions of AIDS activists, guidelines are often perceived as limiting or judgemental. Many men feel that modifying or eliminating a central sexual practice means they are "no longer Gay". Sex is perceived as the cement in the Gay male community: Gay men fear that if sexual ties are reduced or de-emphasized, the community will lose its unique identity and disintegrate.


The safe sex message is quite simple. It was stated elegantly by one safe sex educator, a Gay man with AIDS: "Whatever you want to do, you can probably do it safely." That means continuing activities that do not involve exchange of semen, blood, feces and possibly urine and saliva if there is reason to believe that quantities of blood may be in them. When you engage in activities where these fluids will be present, use a condom, surgical gloves or dental dams. It is that simple.

More difficult is how to actually incorporate those simple changes into highly structured community practices and complexly integrated personal identities. You have to change group values, self-esteem and individual behaviors to conform to new norms required by this health crisis.

Some techniques used by educators working with youth are particularly innovative and address three areas of changes. The condom race makes the physical act of safe sex more familiar. Two teams form, each with a dildo. A team member puts a condom on the dildo then hands it to the next player who must take off the first condom before putting on a second. A ranking exercise teaches the logic of decision making. Each participant is given a card with a sexual practice. Players must discuss the sexual practices on their cards, then rank themselves in order of risk. Finally, role playing allows social questions to come to the fore. Couples or small groups are given seduction scenarios and practice bringing up safe sex issues.

Changing group attitudes is much more difficult. A variety of studies have looked at what makes Gay men successful in executing safe sex changes. Early studies rated high: positive Gay identity, a belief that one can make change (self-efficacy), and seeing or remembering the image of someone who has AIDS. More recent studies tried to correlate knowledge of HIV-antibody status with ability to maintain behavior changes. These studies show that ongoing contact with supportive people who can answer AIDS questions is more effective than knowing if you are HIV-positive or HIV-negative.

No single event or piece of information has the magical power to make people practice safe sex. But community mores and reinforcement by people who understand the complexities of Gay male sex identity and practice can make a very big difference. Safe sex is a group activity of transforming our sexual culture, not an individual ritual of trotting off for secret tests or sexual reprogramming.

Claiming the History of Safe Sex Organizing

WOMEN BUY CONDOMS, TOO

Like Gay men, women also have self-esteem problems - "Who cares if I get AIDS?" - which inhibit their ability to make safe sex changes. But unlike Gay men, straight women don't participate in a sexual economy where they have equal power in the creation of mores. While Gay men complain of boredom or loss of Gay identity if they practice safe sex, women must fear their male partners' violent responses to their safe sex suggestions.

Women report being beaten or threatened if they insist on using condoms. Not only are most women at a physical and economic disadvantage relative to their male sex partners (and we're often talking husbands here), they are in the position of having to ask men to put on a condom.

Heterosexuals exist in a much less articulated sexual culture than Gay men. Women find it difficult to direct their partners away from intercourse - Gay men can choose a much wider range of activities which have always been safe.

Class and geographic region add yet another meaning to condom use. Among heterosexuals, the condom is already laden with great symbolic meaning - far beyond the petty complaints about cutting down on sensation, or being a hassle. Both men and women have come to associate condoms with "dirtiness". Condoms in the post-Pill era are thought to be used primarily in prostitution, or by people too young to acquire other forms of birth control.

In this era when most birth control is designed to exist inside a woman's body, most people in the highest risk age groups have never had to deal with male-centered contraception control or STD. This is strongly reflected in the new condom marketing campaigns which are aimed at women. By several counts, women now comprise half of the condom buying market. If we consider that Gay men comprise a large percentage of the male condom buyers, we can only conclude that straight men represent the greatest educational stumbling block in heterosexual safe sex.

IV DRUG USERS CAN CHANGE THEIR HABITS

Drug use education has also had its problems. Doctors are reluctant to view IV drug users as a community with social patterns that dictate drug use practices. They view IV drug use as individualistic, and drug users as uneducatable. They fail to recognize the wide range of drug use risks, and design appropriate material. This work has been left largely to community-based, grassroots drug educators. I have found drug use education to be much less authority-ridden than sex education. Peer educators are the norm. Gay safe sex education has become increasingly professionalized in the same period that drug education has been made more street wise.

Studies of New Jersey drug users show a high level of education about AIDS and about IV transmission. Respondents knew techniques for safer IV use and many are decreasing their sharing of needles, and other mixing apparatus. However, they are impeded by the lack of free new needles, and the fear of being arrested while carrying works - which is a sure way of knowing the status of your needles. Most wait until they have gotten their drugs and then attempt to find a clean needle, a process similar to cooking your favorite food, then having to wash your dishes before you can eat.

The differences between heroin use and cocaine use also strongly affect IV drug risk. Hard core heroin addicts more often have their own works, plan to get drugs in a more rational manner, and shoot up less often than cocaine users. Those with hardcore cocaine habits may shoot up a dozen or more times in a day. Recreational IV cocaine users frequently do not recognize their risk. This is particularly true among "yuppies" who think "drug user" means your local street corner junkie.

As we continue the safe sex transformation in our community, and lend advice to our heterosexual friends, we must remain true to the roots of Gay liberation. Our assertion that Gay sex (or any sex) was good, did not mean unlimited, unthoughtful sex. We sought healthy sex, and we stressed psychological health in the early days of our movement. The quests for healthy expression of our love and lust take a new form today, but we cannot allow safe sex to become rigid or moralistic.

SAFE SEX IS PART OF GAY LIBERATION

Safe sex describes specific practices that prevent exchange of body fluids. Safe sex is not a moral category to sweep up sexual practices with which we feel uncomfortable for other reasons. S/M sex can be safe. Anonymous sex can be safe. Bi-sexual sex can be safe. Monogamy is not in itself safe, and, though a valid option for any number of reasons, it carries its own dangers - spouse abuse and all the traditional hazards of marriage. Celibacy (let's get rid of the term abstinence) is safe and has always been a choice of Gay men and Lesbians, even though we did not like to admit we weren't "getting any".

Safe sex is a large agenda item for our community today. But it must be pursued in a context that gives us control over how the safe sex message is articulated and how safe sex norms are enforced. It is hard to persuade those who do not yet engage in safe sex to do so if the state continues to have the power to arrest us for sodomy. It is hard to promote self-esteem when our governor is so homophobic. It is hard to talk about our experience of AIDS and influence others to reconsider their sexual risks when we can lose our jobs and homes for being

Gay.

Safe sex is part and parcel of the long march of Gay liberation. What began as anarchic, angry resistance in June 1969, must continue as an innovative and strong-willed social movement in the '80s. Safe sex is a tangible example of what we have advocated all along - control over our lives, respect for ourselves, respect from the straight world, community compassion and unity.



listed man for homosexual conduct, Bork wrote, "We find it impossible to conclude that a right to homosexual conduct is 'fundamental' or 'implicit in the concept of ordered liberty...' Private, consensual homosexual conduct is not constitutionally protected."

—In a speech before the University of San Diego Law School, Judge Bork explained his judicial philosophy as a "strict intentionalist," saying he would have "no warrant to displace a legislative choice that prohibits certain forms of sexual behavior."

"Judge Bork's repeated rejection of our standing as a class with vested civil rights protections makes him unsuitable for a position on the Supreme Court," said Basile.

Members of the Gay and Lesbian community and their supporters must act, and act promptly, to urge their senators to reject the Bork nomination.

POWERFUL NEW HIV ANTIBODY

ANNOUNCED AT BAYLOR

WACO, TX (GON) - A pair of researchers from the Baylor College of Medicine have discovered an antibody which, they say, prevented transmission of the AIDS virus from infected cells to healthy cells in the test tube.

Drs. Nancy and Tse Wen Chang have developed a preparation called a monoclonal antibody which, in the test tube, targets cells infected with the AIDS virus itself, according to the Montrose Voice of Houston. This targeting ability is important, since AZT, the only federally-approved treatment for AIDS also affects healthy cells, causing side effects.

"We must emphasize that cannot be called a cure for AIDS and that any treatment of patients based on our findings is probably at least two years away," said Nancy Chang. "Any application for human treatment must be considered very preliminary."

The Changs must now test the antibody's effectiveness on HIV-infected human blood cells in the test tube. If these tests, which are expected to take several months, are successful, the research team will seek approval from the Food and Drug Administration to test the preparation on people who have AIDS.

Dr. Joseph L. Melnick, who chairs Baylor's virology and epidemiology department, said that Chang's discovery is "perhaps 1,000 times more potent, perhaps more so, than any antibody that is known about until this time in being able to neutralize the virus."



APATHY ELECTED MECHAM - NOT VOTERS

Apathy had reached a new peak. 40 percent of the people voting put him in office and less than 54 (53.26) of the people who were eligible to vote, took the time to do so. You fail to give the youth of this country the best education possible, is detrimental not only to them, but to the future of the country. It is an admitted goal to lower the state budget, but to cut \$21 million from the education budget is not the way to go. Our country was founded as, and remains a Republican state. Our founding fathers knew that Democratic principles had to be installed to help guard our freedoms and to prevent an abuse of power by elected officials.


After serving 20 years in the Army, seven of it in Southeast Asia, I have no need of an elected official stating that there is too much democracy in this country.
